5. **Presentation of Year over Year Context** : Student Outcomes and Trends

The purpose of this item is to provide context on what the “landscape” looks like for student enrollment and outcomes in preparation for the assessment of adjustments needed for the 2022 Scale of Adoption Assessment (SOAA). Questions we will address in this brief presentation include: Which student populations have left? What is the enrollment trend over the past 3 years? What has the impact been for student populations (outcomes, financial aid applications, completion)?

6. **Presentation of Three-Pronged Marketing Efforts:** General & Targeted Public Information Office Efforts, Career Education (Full Capacity Marketing) and Student Services (Interact)

The purpose of this item is to share some retention/recruitment/engagement strategies underway with the College’s Public Information Office (PIO), as well as the contract work with two external marketing firms targeting Career Education students and different student populations. This presentation will also serve to inform the committee’s assessment of the SOAA.

7. **Review and update of Scale of Adoption Assessment (SOAA)** – 40 minutes

Each year the CCCC requires California Community Colleges to provide an update on progress towards their Guided Pathways efforts as outlined in each college’s Scale of Adoption Assessment. The review and input at College of the Canyons happens in the (IE)² committee, College Planning Team, Academic Senate, Classified Senate and Associated Student Government. The College must certify its 2022 SOAA by March 30, 2022.

The purpose of this agenda item is to introduce the Scale of Adoption Assessment, explain the purpose and benefits, provide background on the SOAA and History at COC, and solicit committee input through breakout rooms on needed adjustments. Specifically, breakout rooms will be used to gather input on anything that committee members think is missing from the SOAA update, as well as anything that is misrepresented/mischaracterized or anything that needs to be expanded upon.
