The Committee was advised the FieldTurf for which they approved expenditure of Measure “C” funds on January 29, 2003 has been installed.

The Committee requested a status on the Community Recreation Agreement being developed between COC and the William S. Hart Union School District, which would amount to a contribution to the District in the amount of \$505,000 in 2002/2003 to cover half of the cost of the FieldTurf. They were informed the contract should be on the June 11, 2003 agenda for Board approval.

- ✓ On May 14, 2003 the Board of Trustees approved a bond issuance not to exceed \$17,500,000.
- ✓ The District has earned \$350,000 in interest income from Measure "C" dollars.
- ✓ The Board of Trustees is considering approving the retrofit of the stadium restrooms and the resurface of the track, which may fall within the Repair and Renovation of Existing Facilities section of the Measure "C" Projects.
- ✓ Committee Member Weygand is having difficulties attending the meetings due to eye problems and has submitted suggestions to the Committee on obtaining a "taxpayer representative" replacement for him on the Committee.
- ✓ Following the meeting, the Committee members participated in an informal tour by Mr. Schrage of the Performing Arts Center, which is under construction.
