College of the Canyons:

- ✓ Offers 83 degree programs and 71 certificates;
21 transfer degrees in place; +2 pending!
- ✓ Provides higher education at both sides of our Valley
 - ❖ The Canyon Country Campus (CCC) was filled to capacity day one of operation
- ✓ Presents an opportunity for quality education through our University Center—*all the way up to doctorate degrees*—without leaving the SCV
- ✓ Gives high school students a head start on college education through the Academy of the Canyons (AOC)



Access

Academy of the Canyons

Located on the College of the Canyons campus in the University Center, a 2015 National Blue Ribbon School, Academy of the Canyons Middle College High School (AOC) is a public alternative to the high schools in the William S. Hart Union High School District

- ✓ From 2000-2009, AOC only served grades 11-12, which was expanded to 9-12 in 2009 after merging with the district's Early College High School
- ✓ AOC services up to 400 students per school year
- ✓ On average, students complete one year of transferable college level courses and have the opportunity to earn an Associates Degree by high school graduation; in fact **15 students in the Class of 2015 earned Associates Degrees by the time they graduated high school!**

Transfer Degrees Guarantee Junior Standing, Priority Admission

- ✓ California Community College students who have earned a transfer associate (AA/AS-T) degree are guaranteed junior standing and priority admission consideration over all other transfer students when applying to a CSU baccalaureate (BA/BS) degree program that has been deemed similar to the student's community college area of emphasis.
- ✓ Once admitted to a similar baccalaureate (BA/BS) degree program, the transfer associate degree student will only be required to complete 60 additional prescribed units to qualify for the similar baccalaureate (BA/BS) degree.

COC ranks among the top 5 community colleges in its region offering 20 or more transfer degrees

- ✓ College of the Canyons is the only public institution of higher education in Santa Clarita
- ✓ Through its University Center students have access to 41 baccalaureate, masters, and credentialing programs on the college's Valencia Campus
- ✓ Since 2002, just over 2,339 students have received their bachelor's and / or graduate level degrees through programs offered in the University Center

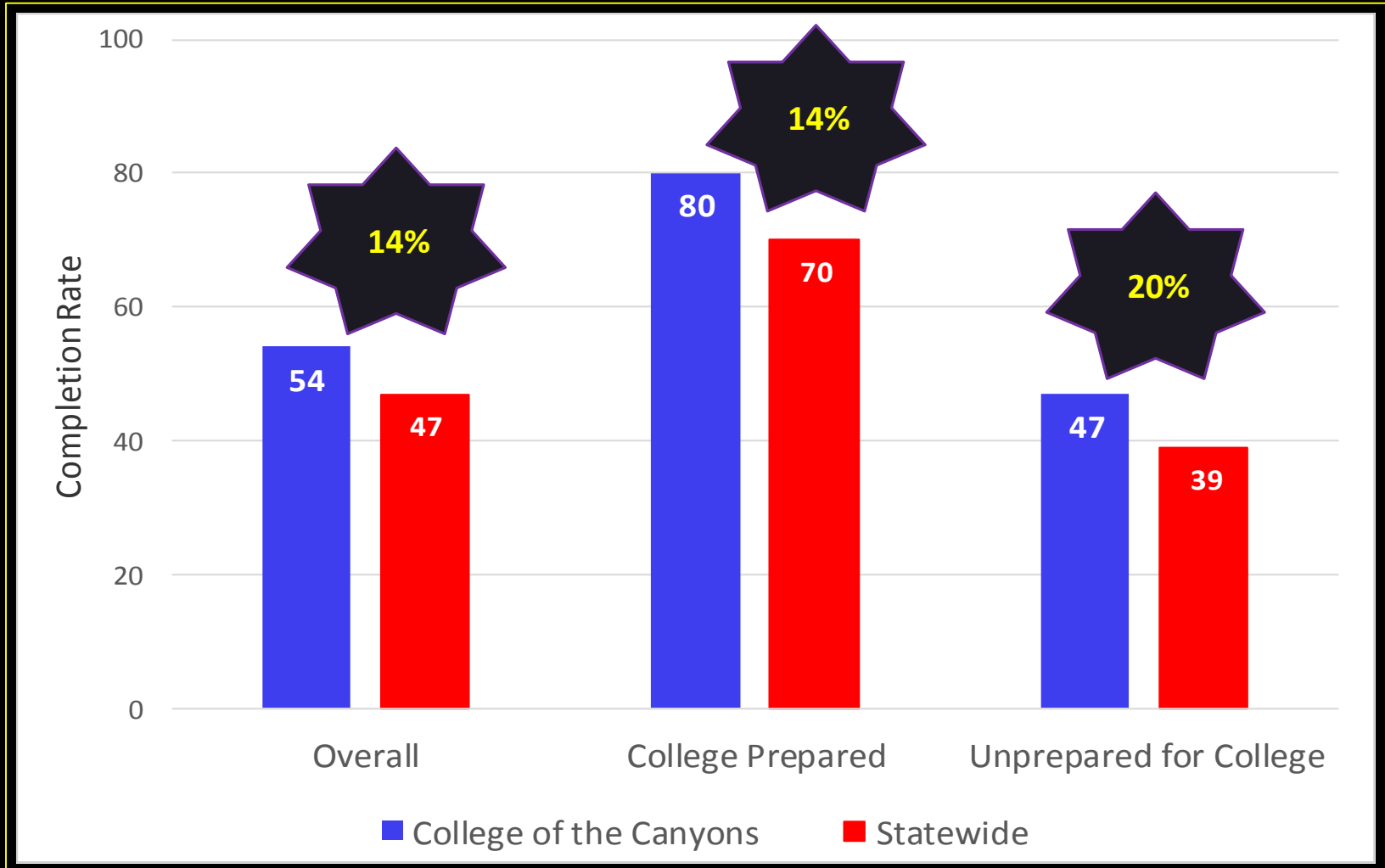

- ✓ The college’s acceleration *efforts benefit more than 5,000 students* per year resulting in one of the most robust offerings of accelerated math and English courses *in California*



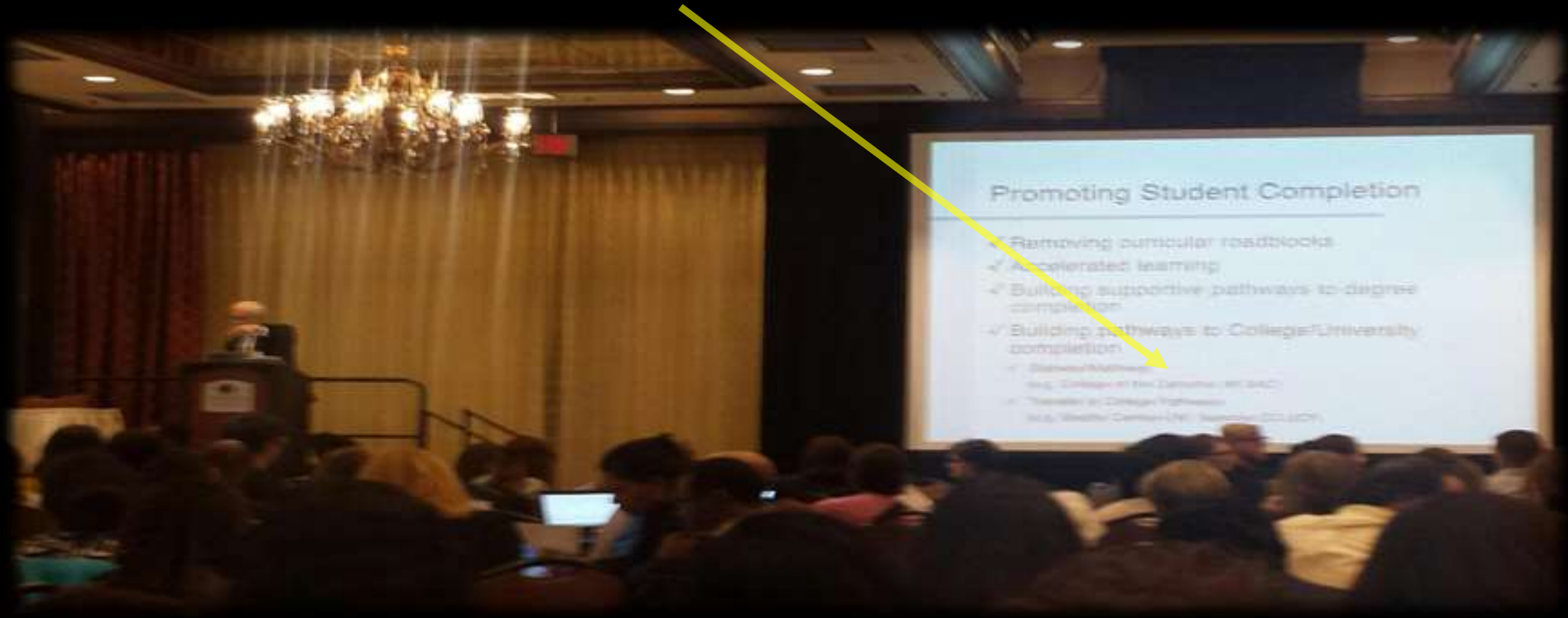

New Programs Make COC Stand Out

Always looking for better ways to deliver education and help ensure success to today's students, College of the Canyons' faculty and staff have introduced innovative programs like:

✓ OER or Open Educational Resources

- ❖ In short--OER provides access to e-text books, eliminating the need for students to spend hundreds of \$s on hard copies
- ❖ Instructors have unlimited access to the learning materials that may be freely used and reused, without charge!

✓ ZTC or Zero Textbook Cost degrees, *an outgrowth of the OER movement*

- ❖ By creating courses that require ONLY the use of OER learning materials, instructors free students from the financial burden of textbooks...funds which may be re-directed toward other areas of learning and possibly reduce the amount of student loans
- ❖ The Governor's 2016-17 budget has \$5 million proposed toward the ZTC initiative, and COC has made steps to move forward with this program

New Programs Make COC Stand Out

✓ MakerSpace

- ❖ An interdisciplinary innovation studio dedicated to the art and science of ideas!
- ❖ Will be outfitted with rapid prototyping machines such as **3D printers/scanners, CNC machines, lasers, vinyl cutters, plastic injection molder** and more!
- ❖ Allows people to make almost anything! Gearboxes, games, replacement parts, pewter castings, and wearable tech
- ❖ Open to the college partners, students –very exciting!
- ❖ Set to open Mid-April



How Does COC Support & Partner w/Local Businesses?

COC's GOAL

Increase individual and regional economic competitiveness by providing California's workforce with relevant skills and quality credentials that match employer needs and fuel a strong economy.

COC's Economic Impact on the Santa Clarita Valley

- ✓ The overall impact of COC on the local business community during the analysis year* amounted to **\$313.6 million in GRP**, equal to the sum of the operations spending impact, the student spending impact and the alumni impact.
- ✓ By comparison, the contribution that the College provides to the community on its own is nearly as large as the entire SCV Accommodation & Food Services Industry

COC was recently recognized for its wide range of educational support, outreach and volunteer programs directed at serving local students and community members by The Santa Clarita Valley Association of California School Administrators (ACSA)

COC stood out to The Santa Clarita Valley Association of California School Administrators through

- ✓ The continued opportunity for high school students to concurrently enroll in tuition-free college courses at COC

A Local Economic Catalyst

The Economic Development Department

COC works with its in-house Economic Development Division, as well as SCV Economic Development Corp., the Chamber of Commerce and VIA to ensure it offers training and is responsive to major industries in Santa Clarita

In the last year, the college's Economic Development Division:

- ✓ Generated \$3.9 million in grants to offer cutting-edge training for 866 companies and over 5,000 individual employees
- ✓ Participated in, and contributed to, 56 business startups
- ✓ Helped clients create 341 jobs
- ✓ Assisted clients achieve a \$17.4 million increase in sales and raise \$26.9 million in new capital
- ✓ Partnered with several SCV economic development focused organizations to attract a corporate headquarters to the SCV with 500+ employees

A Local Economic Catalyst AJCC (WorkSource) Program

The Santa Clarita America's Job Center of California (AJCC) AKA WorkSource is operated by the college under contract to the City of Santa Clarita

- ✓ Exceeded the annual goals for **enrollments and placements by over 15%**
- ✓ **Hosted 12,111 student and community visitors** to assist them in securing employment
- ✓ Enrolled **117 individuals** in a comprehensive program that resulted in an 84% placement rate
- ✓ **Held 48 recruitments** and job fairs and **delivered 260 workshops** for jobseekers and employers
- ✓ Developed new partnerships at no cost to the center with:
 - ❖ South Bay Workforce Investment Board to provide 3 support staff through the Transitional Subsidized Employment (TSE) Program
 - ❖ Goodwill of Southern California to provide a Career Advisor and a Business Services Rep
 - ❖ Salvation Army to provide 1:1 Career Advising for Veterans
 - ❖ Title V program to provide 2 part-time staffers for resource room support
 - ❖ COC's Volunteer Program that provided more than 12 volunteers during the year

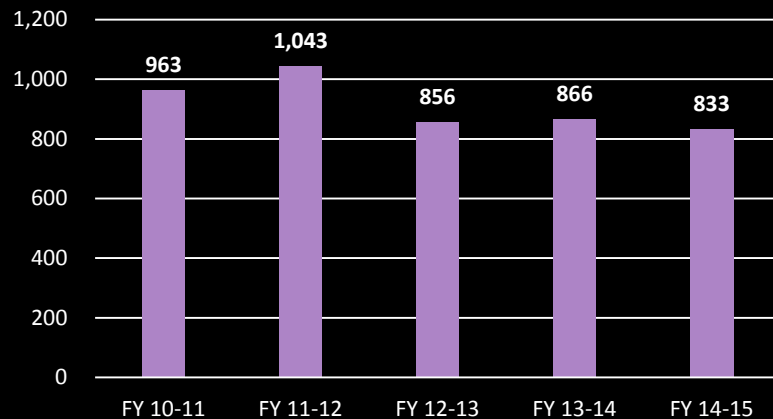

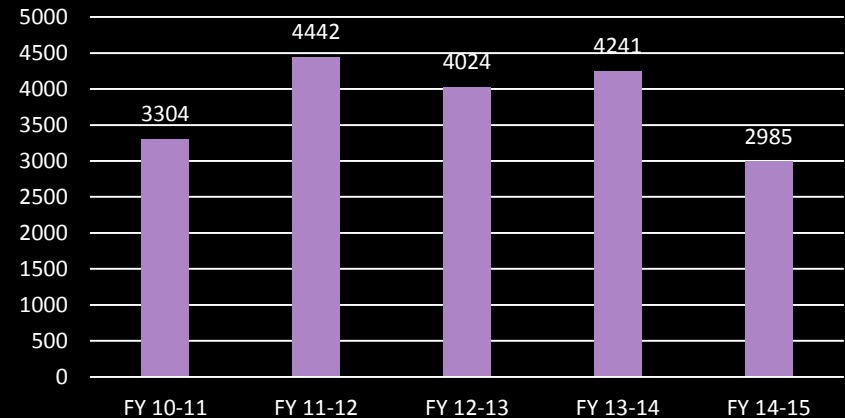

Since 1967

We've Come A Long Way, Baby!

- ✓ Officially approved by voters -**1967**
- ✓ College of the Canyons began instruction in classrooms located on the Hart High Campus on Sept. 22 – **1969**
 - ❖ The Hart High campus filled an urgent need but was ill-suited to accommodate college students for long. College classes had to begin in the afternoon after the high school students departed.



Did you know? COC's first classes were actually held on the Hart High campus? First day: Sept. 22, 1969.

❖ We leveraged \$240 million in local GO Bond money to obtain \$70.1 million in State matching dollars and \$33.7 million in local matching dollars.

Since the 2006 Measure M Bond Measure

- Measure M \$160,000,000 Local Bond was based on the 2007 2012 Educational & Facilities Master Plan
- The District leveraged **\$140 million; obtained \$101.7 million in matching funds, interest on project funds, and premium bonds for a total revenue stream of approximately \$241.7 million.**

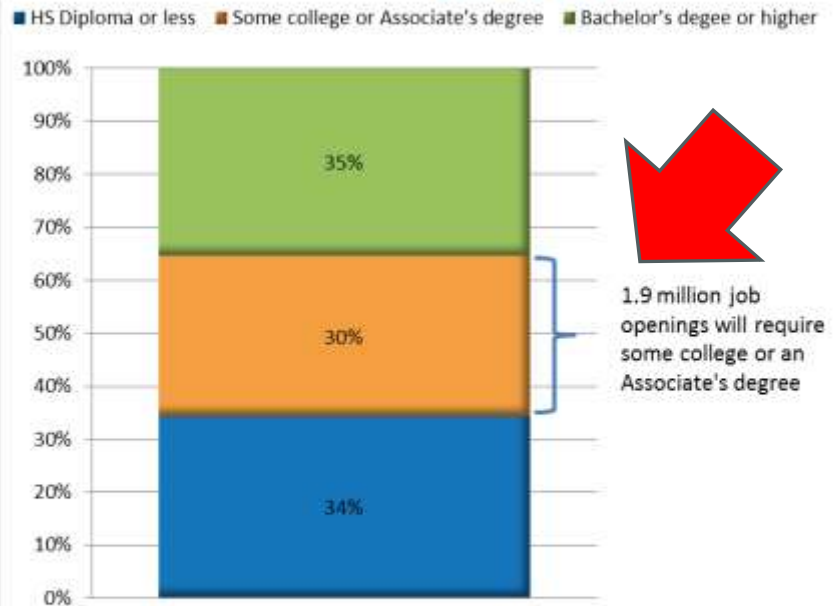

There's a Serious Need for Job Training

- ✓ 1.9 Million job openings in California between 2015 and 2025 will require some college or an Associate's Degree
- ✓ *In the 1970s, 28% of jobs required more than high school training*
- ✓ By 2020, 65% of job openings will require some postsecondary education or training
- ✓ Top job openings in California will include Nursing, Web Developers, Computer Support Specialists, Medical Lab Technicians, and Emergency Medical Technicians

Especially in Nursing/Allied Health*

- ✓ By 2030, we will be more than 193,000 nurses short of the need in California
- ✓ The Nurse Workforce Report Card gave California a “D” grade for the number of nurses
- ✓ California’s nurse to population ratio has ranked 48th in the Nation for the past 10 years



Add to Those Facts, The Changing Employment Landscape

- ✓ The top 10 in-demand jobs in 2010 did not exist in 2004
- ✓ We are currently preparing students for jobs that don't yet exist...using technologies that haven't been invented...in order to solve problems we don't even know are problems yet
- ✓ The U.S. Department of Labor estimates that today's learner will have 10-14 jobs by age 38
- ✓ 1 in 4 workers has been with their current employer for less than a year
- ✓ 1 in 2 has be there less than 5 years

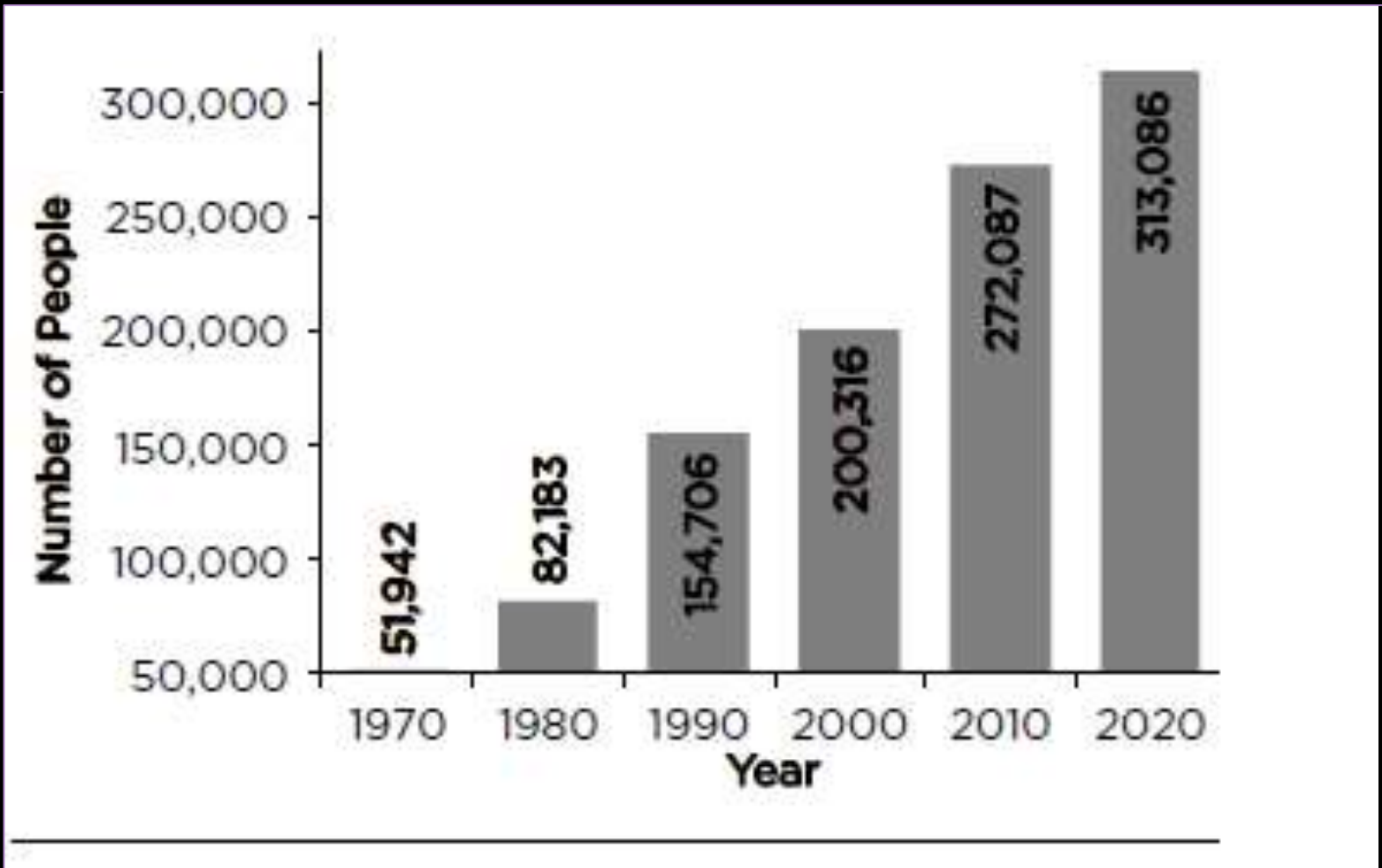

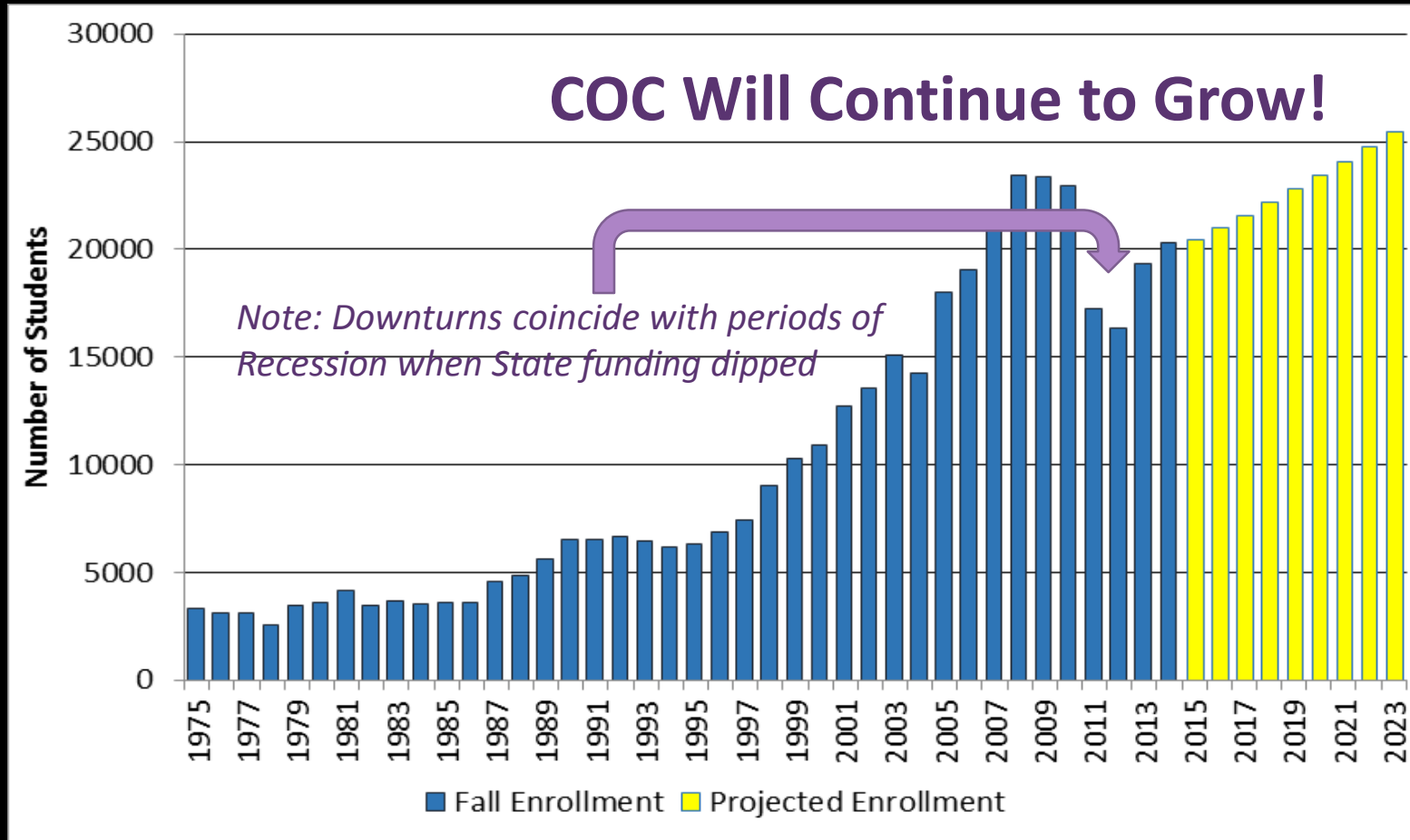

Demand Will Continue To Increase

...bringing more students to COC and adding to the need for additional degrees and certificates!

Student enrollment continues to grow! In fact, enrollment is expected to reach 30,000 students within the next decade.

To continue providing a high-quality education that prepares students for four-year college and future careers, COC must:

- ✓ Increase enrollment capacity by building out the Canyon Country Campus
- ✓ Update classrooms, labs, technology and equipment at the Valencia Campus
- ✓ Improve parking and accessibility

And, With So Much Demand, We Need More Space!

The College Does Not Have Enough Classrooms, *Especially In The Mornings And Evenings*

- ✓ Currently, there are **4,400 people who have applied but unable to enroll** and **4,000 people on the wait list** each semester for one or more classes
- ✓ This is especially problematic for working adults who can only take classes at night
- ✓ Projected enrollment growth will severely impact the College
 - ❖ **Facilities are needed at the Canyon Country Campus as 1 solution to this problem**
- ✓ 1,988 FTES already generated at CCC for 15/16, and on pace to exceed 2,000 FTES for the 6th straight year.
- ✓ **CCC is larger than 8 Community College districts**

And, With So Much Demand, We Need More Space!

#1 Solution to the Problem?

The Canyon Country Campus Needs Facilities

Consider These Statistics

- ✓ 1,988 FTES already generated at CCC for 15/16
- ✓ On pace to exceed 2,000 FTES for the 6th straight year.

The Canyon Country Campus is larger than 8 Community College districts, yet still needs more room to accommodate the thousands of waitlisted students each semester, as well as those we expect over the coming decade

The Process: Educational & Facilities Master Plan

From growth and jobs data, projections for departments are developed

Over 230 faculty, staff and community members will have been interviewed

- ✓ Review Department Projections (instructional areas)
- ✓ Identify Major Goals
- ✓ Determine what is needed in terms of personnel, equipment and facilities to achieve the projections and major goals.

Comparing the current and future educational needs to the existing physical space results in the Facilities Master Plan

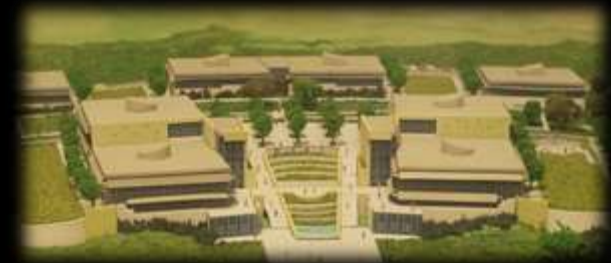

Recommendation To Address Need

**Place a general obligation bond
before the voters on June 7, 2016**

A Local Bond Measure

To update, improve and expand local classrooms and facilities and continue to provide quality education to local students, the Board of Trustees has approved placing a local bond measure on the June ballot

- ❖ Generate \$230 million to improve our local college
- ❖ Cost of \$15 per \$100,000 of *assessed*, not market, value

Pursuing a Bond, *Why Now?*

The timing is right!

- ✓ The College will be eligible for state matching dollars of approximately \$20 Million in the next 4 years and close to \$40 million in 8 years
- ✓ The College has a stable Board of Trustees and administration
- ✓ The College is following a detailed Educational and Facilities Master Plan

Fiscal Accountability

- ✓ Every penny raised by a local measure would be used here in our local community
- ✓ The measure would qualify College of the Canyons for millions in state matching funds that would otherwise be lost to other communities
- ✓ By law, no funds could be used for employee salaries
- ✓ Independent citizens' oversight and annual audits would be required

Why a Bond Measure and Not Some Other Source Of Funding?

- ✓ College of *the* Canyons garners private support from individuals, corporations, foundations, and its business partners, but the needs are far more extensive than these private resources can fund
- ✓ With the enormous and growing backlog of facility needs within the CSU, UC and community college systems, **College of the Canyons will not receive significant state capital outlay funding for at least the next eight years unless we have local matching dollars**
