

Student Health Center Inquiry

At the request of the Student Health Center, the Office of Institutional Development and Technology examined demographic (age, sex, and ethnicity) and special population (EOPS, DSPS, Athletes, Cal-Works, Veterans, and Foster Youth) data for students who have visited the Student Health Center between October 1, 2013 and October 31, 2014. Services provided by the Student Health Center include mental and physical health. Specifically, this research intended to answer the following questions:

- Of students identified as being in a special population, what is the number and percentage seeking Health Center services compared to students not seeking Health Center services and the student population as a whole?
- What is the number and percentage of students seeking health services by type of service?
- What are the demographics of students seeking Health Center services compared to students not seeking Health Center services and the student population as a whole?
- What are the demographics of students seeking Health Center services by type of service received compared to the student population as a whole?

Answers to these questions are intended to help inform the Student Health Center Student Equity inquiry and Substance Abuse and Mental Health Services Administration (SAMSHA) grant.

Question #1. Of students identified as being in a special population what is the number and percentage seeking health center services compared to students not seeking health center services and the student population as a whole? As indicated in Table 1, the percentage of students identified to be in special populations who utilized the Student Health Center is higher than the percentage in which these populations are represented within the overall COC student population; however, the majority of students in the special populations have not utilized the Student Health Center.

Question #2. What is the number and percentage of students seeking health services by type of service? As indicated in Table 2, the majority of students who utilized the Student Health Center sought physical health services only (77 percent), followed by 14 percent mental health only, and 9 percent both physical and mental health services.

Question #3. What are the demographics of students seeking health center services compared to students not seeking health center services and the student population as a whole? As indicated in Table 3, the majority of students utilizing the Student Health Center were female (72 percent), which exceeds the percentage in which this population is represented within the overall COC student population (48 percent). A little less than a third of students who visited the Student Health Center were male, which is less than the percentage in which this population is represented within the overall within the overall COC student population (52 percent).

As seen in Table 4, just over half of students who visited the Student Health Center were between ages 20-24 (52 percent), followed by 25-29 (17 percent). Both age groups exceed the percentage in which these populations are represented within the overall COC student population (33.2 and

10.6 percent, respectively). The remaining age groups of those who visited the Student Health Center, 19 or less, 30-34, 35-39, 40-49, and 50+, represent less than the percentages in which these populations are represented within the overall COC population.

As indicated in Table 5, the majority of students who visited the Student Health Center were Latino and White (38 and 35 percent, respectively). The percentages of Latino and White students who visited the Health Center are similar to the same ethnic groups that did not attend the Health Center. Asian/Pacific Islander and African American students who received services from the Student Health Center also represent less than the percentages in which these populations are represented within the overall COC population.

Question #4. What are the demographics of students seeking health center services by type of service received compared to the student population as a whole? As indicated in Table 6, the percentage of female students utilizing the physical health and/or mental health services at the Student Health Center exceeds the percentage in which this population is represented within the overall COC student population (48 percent), while it does not for male students. Female students were more likely to use Health Center services, especially for health services only and a combination of health and mental health services. The difference was less pronounced for mental health only, although there were still differences between the sexes. For male students, 26 percent utilized physical health services, 76 percent were female and 24 percent were male.

As indicated Table 7, the percentage of students between ages 20-29 who utilized the physical health and/or mental health services at the Student Health Center exceeds the percentages in which these populations are represented within the overall COC student population, while it does not for the other age groups. Notably, the percentage of students aged 19 or less and aged 40 years or older who utilized physical and/or mental health services is well below the percentage in which these populations are represented within the overall COC student population. The majority of students who utilized mental health services only, health services only, or both were between the ages 20-24 (50, 52, and 50 percent, respectively).

As indicated in Table 8, the percentage of Filipino and White students utilizing physical health and mental health services at the Student Health Center is slightly higher than the percentage in which these populations are represented within the overall COC student population. For students who utilized health services only, the percentage of Filipino, African American, and Unknown, students exceeds the percentage in which these populations are represented within the overall COC student population. For students who utilized both services, the percentage of White and Unknown students is slightly higher than the percentage in which these populations are represented within the overall COC student population. Overall, the majority of students utilizing mental health, health only, or both services were Latino and White; however, the percentage in which Latino students utilized services is less than the percentage in which this population is represented within the overall COC population.

Methods

To conduct the analysis, enrollment and special population data from October 1, 2013 to October 31, 2014 were obtained from MIS. Data were merged with Student Health Center records from October 1, 2013 to October 31, 2014. To perform the analysis, data were analyzed using the Statistical Package for the Social Science (SPSS, 2014) and Microsoft Excel (2013).

Recommendations

- Explore ways to increase awareness of Student Health Center services to populations identified as being underserved (e.g., special populations, Latino students, students aged 40+, and male students not seeking physical health services)
- Establish an inquiry group to examine why the underserved populations are not receiving services from the Student Health Center.
