A. PREREQUISITE COURSES THAT MUST BE COMPLETED PRIOR TO APPLICATION TO PTA PROGRAM

Prerequisite courses must be completed with a grade of C or better *before* applying to the PTA Program. English Composition, Anatomy, Physiology, Medical Terminology, and PTA 100 courses must meet an average 2.5 GPA to be eligible to apply to the program. There is a 5-year Recency Requirement for Anatomy and Physiology courses only. Completing program prerequisites does not assure admission to the program. Admission is based on space availability, clinical clearance requirements, and background checks.

B. ADDITIONAL COURSES RECOMMENDED FOR THE ASSOCIATE DEGREE IN PTA*

The following General Education* courses are not mandatory for PTA but are recommended and meet graduation requirements. These GEs do not have to be completed prior to application. If they have been completed prior to application, the grades will be calculated with English Composition, Anatomy, Physiology, Medical Terminology, and Preparing for Careers in Physical Therapy toward the minimum 2.5 GPA requirement. *Candidates with employer documentation of 2000 or more hours of work experience as a physical therapy aide may provide documentation at the time of the application in lieu of taking PTA 100. Then, if accepted into the PTA program, the PTA student can meet with a COC Counselor to have a Major Course Substitution form completed so as to officially waive the PTA 100 requirement.

REQUIREMENTS FOR AN ASSOCIATE DEGREE INCLUDE: COMPLETION OF A MINIMUM 60 DEGREE APPLICABLE SEMESTER UNITS, REQUIRED COURSES FOR THE MAJOR, A CUMULATIVE GPA OF 2.0 OR BETTER IN ASSOCIATE DEGREE APPLICABLE UNITS, GOOD STANDING AT COC AND A MINIMUM OF 12 UNITS COMPLETED AT COC.

Graduation from a physical therapist assistant education program accredited by the Commission on Accreditation in Physical Therapy Education (3030 Potomac Ave., Suite 100, Alexandria, Virginia 22305-3085; phone; 703-706-3245; accreditation@apta.org) is necessary for eligibility to sit for the licensure examination, which is required in all states. Candidacy is considered to be an accredited status, as such the credits and degree earned from a program with Candidacy status are considered, by CAPTE, to be from an accredited program. Therefore, students in the charter (first) class should be eligible to take the licensure exam even if CAPTE withholds accreditation at the end of the candidacy period. That said, it is up to each state licensing agency, not CAPTE, to determine who is eligible for licensure. Information on licensing requirements should be directed to the Federation of State Boards of Physical Therapy (FSBPT;www.fsbpt.org) or specific state boards (a list of state boards and contact information is available on FSBPT's website. College of the Canyons is seeking accreditation of a new physical therapist assistant education program from CAPTE. The program is planning to submit an Application for Candidacy, which is the formal application required in the pre-accreditation stage, on November 1, 2024. Submission of this document does not assure that the program will be granted Candidate for Accreditation status. Achievement of Candidate for Accreditation status has been achieved. Further, though achievement of Candidate for Accreditation status signifies satisfactory progress toward accreditation, it does not assure that the program will be granted accreditation.

THE APPLICATION AND SELECTION PROCESS

It is important to refer to the PTA website for all deadlines and application instructions! A criminal background check will be completed after an invitation for admission into the PTA program is received.

SELECTION & ADMISSION	A multicriteria process will be performed to determine those accepted for Fall 2025 and those on an alternate list. Communication regarding acceptance will begin via email by June 30, 2025. Emails will be sent to the email address included in the online application. Confirmation of Acceptance must be returned via email within 2 weeks of receipt of dated email.

2. APPLY TO COLLEGE OF THE CANYONS	Not a current College of the Canyons student? Before you submit an application to any of the School of Health Professions programs, you will need to apply for admission to the College. Becoming a student is free and easy.
3. SUBMIT OFFICIAL DOCUMENTS TO ADMISSIONS	 If any or all of the following apply, please submit documents to Admissions and Records: 1) Current official transcripts from all colleges attended, except COC (must include all college coursework whether PTA prerequisites or not). If coursework is from the LACCD, please make sure your official transcripts are not electronic copies, but are printed official transcripts from LACCD –must have overall GPA on transcripts submitted 2) For transcripts from other countries, an official sealed foreign transcript evaluation from a NACES approved agency 3) Official military transcripts 4) Official College Board report of ALL AP scores (passed with scores of 3 or above)—not accepted from High School transcript 5) Official College Board CLEP Math score (if applicable and counting for Math credit) Make sure all submitted transcripts are current and include overall college GPA. Please note (this may require ordering updated copy of official transcript to be submitted prior to the deadline)
4. APPLICATION SUBMISSION	Submit an online application for the Physical Therapist Assistant program within the application time period from April 21, 2025, at 12pm - May 19, 2025, at 12pm. Applicants who submit incomplete applications or who are missing any required documents will automatically be ineligible. Your application should include specified contact information, prerequisite verification, uploaded unofficial transcripts, and program specific information. All uploaded documents must be in PDF format. If you are enrolled in a prerequisite course when you submit your application, you must show proof of current enrollment with your submission. Admission into the Physical Therapist Assistant program will be pending until each prerequisite submitted in the application is completed. If you are taking prerequisite courses at another institution, please verify with Counseling that they will transfer to College of the Canyons and meet program requirements before applying. Eligible applicants will be invited to take the TEAS on campus and assigned a date after the application period is closed. Test prep information can be found at https://www.atitesting.com/teas

UPDATE YOUR CONTACT INFORMATION	You are responsible for maintaining a current email address with the Health Professions office and responding to requests for confirmation of your continued interest in admission into the program sent during the year. Be sure to return each such notice by the stipulated date to maintain the admission status.
