Meet the Newswest Board of Trustee: Sebastian Cazares

- Sebastian gave special thanks for the invitation to attend the Open Classified Senate meeting. He also shared some thoughts on the lack of student representation in governing bodies. This was his motivation to run for a seat on the board. He is the youngest board member ever elected at just 20 years old.
- The goal of the Board is to ensure that all groups on campus feel included and that all are given a space to advocate. The college's focus is on advancing diversity efforts. This was seen in the recent "Call to Action" which was supported by Classified Senate, Academic Senate, ASG and the BOT. There is a large LatinX and Chicano student population on campus. He is excited to see that there is an "Intro to Chicano Studies" course which is being taught by faculty member Dr Hernan Ramirez. Sebastian emphasized the need to prioritized equity and this is very important in his role as Board of Trustees. One of his major motivators towards this movement was the recent and unfortunate case of George Floyd and the Black Lives Matter movement. He noted that the reality is that there are many people who have experienced racism in the Santa Clarita Valley area. There is a need to create ongoing actions to improve experiences and conditions for students of color.

- Michael and Andrea have been working together on creating this document. It is important to outline what the CSEA focus is on and what the Classified Senate focus is on. This document has been worked on for the past 5 years. This document has also been reviewed by the statewide CSEA legal department and Jessica Morrow, the current CSEA Labor Rep. to ensure it does not violate the current CSEA contract.
- There are some committees where there is a need to have more classified representation such as PAC-B. There needs to be more clarity about how many seats can be appointed to some committees? The committee procedures may need to be reviewed as well. The goal is to seek active participation from classified members who can be appointed and report back to the Classified Senate. This is a great opportunity for anyone interested in taking on more leadership roles. The Classified Senate President or designee will be responsible for appointing Classified members to various committees. There will be extra training provided.
