NEW COURSE PROPOSALS – DISCUSSION OF NEED

The following new course proposals will be discussed at this meeting with the authors of the proposals to determine the need of adding the course to our curriculum.
The course outlines will not be reviewed at this meeting.

Subject & Number	Title	Rationale for New Course Proposal	Author	Effective
ETHNST-104	Chicana/Latina Feminism in Contemporary Society	AB-1040, commencing with the 2022–23 academic year, requires each community college district to offer courses in Ethnic Studies at each of its campuses. The bill requires that the units earned by students for successful completion of these courses be eligible for transfer and, if applicable, meet the Ethnic Studies general education graduation requirements at the California State University. The bill also, commencing with the 2024–25 academic year, requires each community college district to require the completion of at least one course in Ethnic Studies of at least 3 units as a requirement for a student to obtain an associate degree. COC currently has two courses in Ethnic Studies meeting the Area F requirements, and one more is being resubmitted for review. This course will expand our offerings in Ethnic Studies for students who want to meet Area F requirements and for students who are Ethnic Studies or Social Science majors. HIST-230	The Role of Native Americans in the History of the U.S.	Native American History courses are now a standard option that all colleges should offer to their students as options. Compared to our sister colleges in the region, we are behind recent trends in expanding courses like this that serve diverse student populations, especially our Native American student population which currently numbers at 600. Of that number, over 400 are served in our NASSSP program. This course will meet our college’s commitment to DEI initiatives. We strengthen our DEI reputation in the region by adding a course like this that goes a long way to reflect the identity and lived experiences of our Indigenous student population.	M. Felix	TBD
