Subject & Number	Title	Rationale for New Course Proposal	Author	Effective
GEOGRPH-200	Geography of Disney's Thematic Landscapes	As enrollment becomes more competitive, creating a science course that is not only experiential, but relatable is key, as well as a course that will attract students from outside our community. This course offers a unique pedagogical bridge between theoretical science and practical application. By using Disney’s meticulously engineered environments as a living laboratory, students gain a rare opportunity to observe geomorphic processes and cultural landscapes in a controlled, high-fidelity setting. This approach serves students by transforming abstract concepts - such as geologic time and internal Earth structures - into tangible, observable case studies, fostering a deeper level of engagement than traditional classroom models allow. HLHSCI-107	Food and Culture	This course will provide students with an opportunity to explore the diversity in food across cultures as it relates to health behavior, disease risk, and disease prevention. It will provide foundational information as well as a multi-cultural overview of food and how human nutritional needs are determined within cultures. Topics will include access to local, but healthy, choices and reiterate the importance of human rights and food security as it relates to culturally meaningful food choices.	K. Bronco	TBD
MEA-107	Writing the Short Script	This course is designed to introduce students to the fundamentals of script writing for short films and television. Students will learn the different writing methodologies that can be applied to short films, half-hour and hour-long episodic and serialized TV and anthologies, animation, and web series. The focus is on creating a compelling short script for the appropriate format. This course is unique from MEA 108 and 208, which both focus exclusively on feature film script dynamics and writing. NC.ARCH-100A NC.ARCH-100B	Architect Registration Examination (ARE) Prep California Supplemental Examination (CSE) Prep	These courses will prepare students for the multi-division Architect Registration Examination (ARE) and the California Supplemental Examination (CSE) required for licensure from the California Architects Board (https://www.cab.ca.gov). On October 1, 2025, a state regulatory change went into effect allowing candidates who seek a California architect license to receive testing authorization eligibility for the ARE and CSE exams without the need to first document architectural training and educational experience as was previously required under the regulations. This regulatory change creates a vocational preparation need for students in the Bachelor of Science in Building Performance and Associates of Architectural Drafting and Technology degree programs at College of the Canyons, as well as students at other local community colleges, preparing them for the California architectural licensure exams. NC.PTA-100	Preparing for Careers in Physical Therapy	PTA 100 is the introductory course to the profession on the credit side. This proposal is to simply mirror that course on the noncredit side. The course is designed for students interested in applying to PT (entry-level Doctorate) or PTA Programs. It is a prerequisite for application to the COC PTA Program. We've offered it 5 times so far since PTA was established. Some students who are not sure whether or not PT is the right fit for them sign up for the course for credit but drop the course when they find out that it carries some academic rigor and isn't just a survey course. Allowing such students to take the course in the School of Personal and Professional Learning will let them get a comprehensive overview of the profession without the risk of a negative grade. If they later want to get credit for it so they can apply to the PTA program they can simply convert it by going through the normal process.	D. Pevsner	TBD
