#### **NEW COURSE PROPOSALS - DISCUSSION OF NEED**

The following new course proposals will be discussed at this meeting with the authors of the proposals to determine the need of adding the course to our curriculum.

Subject & Number	Title	Rationale for New Course Proposal	Author	Effective
ADMJUS-200	Foundations of Modern Policing: The Peelian Principles	The highly publicized and controversial incidents of police misconduct have resulted in significant public and legislative calls for changes in policing practices. Examination of academic offerings reveals a gap in ethical courses in education, specific to the criminal justice system. Robert Peel is known as the "Father of Modern Policing." Peel penned 9 principles of ethical and moral conduct expected by his police officers. These principles are known as the "Peelian Principles." An analysis of every recent police misconduct case results in a violation of at least one of the nine established principles. This course addresses law enforcement ethics in an indepth study of the Peelian Principles in an effort to prepare our students for rewarding, ethical, and moral careers in the criminal justice system. This course will also serve as a core requirement in the new and upcoming Modern Policing degrees.	L. Alvarez	TBD
HLHSCI-113	Social Determinant of Health, Disparities, and Equities	Transfer model curriculum List B is an area without enough support specifically relating to the Public Health degree. Developing this course as an option for the degree will strengthen the knowledge of students pursuing this career pathway. Providing a direct means to closer relate both the personal and social determinants of health through the examination of the role individuals play in their own health and well-being will allow valuable insight into the importance of Public Health. In addition, students being able to explore the environmental, social, structural, and cultural factors that impact individual, community, and public health is critical. Because this course specifically addresses the Public Health disparities and inequities in sexually diverse, gender, racial, and minority populations, providing a strong culturally competent course that bridges the health equity gap and improves population health will ensure students possess the skills to best handle these concerns. - -IDEAA Images. Chris Boltz and Erin Barnthouse shared their IDEAA Images.
- -Noncredit Report. Patrick Backes updated the Committee on the Noncredit Approvals from the 3/11 Noncredit Curriculum Committee Meeting.
- -Local GE Grade Discussion and Vote. The Committee took a vote on a recommendation to the Academic Senate on the new Local General Education Grade Policy. The results of the first round of voting are as follows:

#### Option 1: All GE Grades = D (or higher) to Pass

- This option is the default if we don't select any other option. A D has been & would still be the grade needed to pass GE courses in areas such as Natural Sciences, Arts & Humanities, Social & Behavioral Sciences, and Ethnic Studies.
- A D would also be considered passing in Math, English, and Oral Communication.
- This is the model that LACCD and Chabot College have chosen (& I think West Valley and Mission College).

The Curriculum Committee recommend to the Academic Seante to adopt Option 3 for the Local General Education Grade Policy.

The Committee then voted on whether a C minus will count as a passing grade for our local GE requirements. The Committee voted 11 to 4 to allow a C minus to count as a passing grade and recommends this option to the Academic Senate.

- -Local GE Courses. The Committee reviewed possible course additions to the new Local GE categories effective Fall 2025.
- -Common Course Numbering Update. Tricia George reviewed Common Courses Numbering Phase II and III timelines and next steps.
- -Five Year Revision. The Committee reviewed courses on the Five-Year Revision list that have not yet been submitted to stage 2, and courses that are read for the Stage 4 review.
- -Announcements. Tricia George reviewing upcoming important dates in April.
