Clinical Laboratory Scientist Program	Certificate of Achievement	<p>Revised program description to read: <i>Clinical laboratory scientists are integral members of the allied health care team that perform diagnostic testing on blood, body fluids, and other biological specimens to provide healthcare providers (physicians, nurses, pharmacists, and other members of the healthcare team) information that is utilized in making critical decisions for treatment and monitoring therapeutic interventions. The Clinical Laboratory Science training program will offer a didactic and clinical practicum curriculum in the clinical laboratory sciences that is approved by the California Department of Public Health and Laboratory Field Services (CDPH/LFS). Eligible applicants will have a CDPH/LFS issued Medical Laboratory Technician (MLT) license and a Clinical Laboratory Science (CLS) Trainee license. Selected eligible applicants will participate in clinical placement interview process at the affiliate clinical training sites. Enrollment in all CLS program courses requires clinical placement at an affiliated clinical site. To qualify for a CLS license in the state of California, completers of the certificate program must also submit documentation of the required practicum hours in a CDPH/LFS approved training site. Total major certificate units required now 36.5 units due to reduction in CLS-212 & 213 units.</i></p>	H. Chu	Fall 2026
Emergency Medical Technician	Certificate of Specialization	<p>Revised program description to read: <i>Prepares students for certification and employment as an Emergency Medical Technician, including emergency department clinical and ambulance ridealong. Health clearance and background check required prior to start of clinical rotations. Upon successful completion according to the requirements listed in the current EMT program handbook, students are eligible to take the National Registry EMT examination. The course meets the U.S. Department of Transportation (DOT) National EMS Education Standards (DOT HS 811 077A, January 2009) May be repeated if used for legally mandated training. Admission into the Emergency Medical Technician Program, completion of required Accreditation and local prerequisites or equivalent, and compliance with additional Accreditation and local legal and medical requirements are required.
