# Paralegal Studies Student Survey: Spring 2024

#### **Introduction and Methods**

At the request of the Paralegal Studies department, the Institutional Research, Planning and Institutional Effectiveness Office conducted a survey to gather data from students enrolled in Paralegal Studies classes during Spring 2024. The purpose of this survey was to assess satisfaction with various aspects of the Paralegal Studies program in order to help direct program planning. These data will also be used for reporting requirements for the American Bar Association (ABA). Surveys were initially distributed through Survey Monkey on May 6, 2024 with a reminder sent on May 13, 2024. To improve the response rate, surveys were also distributed through Survey Monkey link by Paralegal Studies faculty members to their students between May 6, 2024 and May 30, 2024. Of the 206 students who were invited to participate in the survey, 69 students completed the survey, resulting in a response rate of 34% as compared to 67 students (46% response rate) in Spring 2023. Among those who responded in Spring 2024, 32 (46%) respondents replied using the initial email link and 37 (54%) respondents replied to the faculty provided link.

#### **Research Results**

# **Awareness of the Paralegal Studies Program**

Respondents were asked to indicate how they heard about the Paralegal Studies program. Forty-three percent of the respondents indicated that they heard about the program through the College of the Canyons website, followed by web research (28%), counselors (10%), recommended by a friend (6%), and from a program graduate and someone at work (1%, each). Ten percent of the respondents (7 students) indicated that they heard about the Paralegal Studies program through "other" sources; specifically, through the ABA website/certification (2 students), family members (2 students), personal research (2 students), and the Cal-Law Scholars Program (1 student).

# **Course Length Preference**

More than half of the respondents indicated that they prefer to take 16-week courses (57%), followed by 8-week courses (36%) and 5-week courses (7%).

# **Satisfaction with Course Modality**

The majority of respondents indicated that they are "satisfied" or "very satisfied" with their current course modality (see Table 1).

# **Recommended Sequence of Courses**

The majority of respondents (87%) indicated that they are aware of the recommended sequence of courses in Paralegal Studies. Of the respondents that are aware of the recommended sequence of courses (N=60), the majority (78%) indicated that they follow the recommended sequence of courses. Of the respondents that follow the recommended sequence of courses (N=46), the majority (70%) indicated that they find the sequence of Paralegal Studies courses "helpful or "very helpful", while 9% indicated that the sequence of Paralegal Studies courses are "somewhat helpful" and 22% indicated a "neutral" response. No respondents indicated that the sequence of the Paralegal Studies courses are "not at all helpful".

# Satisfaction with Various Aspects of the Paralegal Program

Respondents were asked to indicate their level of satisfaction with various aspects of the Paralegal Studies program. More than 75% of the respondents indicated that they were "satisfied" or "very satisfied" with all surveyed aspects of the Paralegal program (see Table 2).

As indicated in Table 2, responses from Spring 2024 differed from results from Spring 2023. Specifically, the percentage of respondents that are "satisfied" or "very satisfied" with the following aspects of the Paralegal program decreased by more than 5 percentage points in Spring 2024:

- Placement/internship services (decreased 11 percentage points in Spring 2024)
- Faculty, overall (decreased 8 percentage points in Spring 2024)
- Library staff (decreased 6 percentage points in Spring 2024)

#### **Alumni Association**

More than two-thirds of the respondents (68%) indicated that if the Paralegal Studies program started an alumni association they would plan to become a member after graduating from the program, while 24% of the respondents are not sure yet and 8% of the respondents would not plan to become a member of the alumni association.

## **Employment Information**

#### **Current Employment**

Of the respondents that provided their current employment status (N=69), 51% indicated that they are employed full-time, 29% indicated that they are employed part-time, and 20% indicated that they are unemployed.

#### Employment in the Legal Field

Of the respondents indicating that they are currently employed (N=55), more than half of the respondents (55%) indicated that they are not currently employed in the legal field, while 45% of the respondents indicated that they are currently employed in the legal field.

#### Working as a Paralegal

Of the respondents indicating that they are currently employed and working in the legal field (N=25), just over half of the respondents (52%) indicated that they are not currently working as a paralegal, while 48% indicated that they are currently working as a paralegal and only seeking a degree.

#### **Additional Comments**

Respondents were asked to provide any additional comments or suggestions they may have for the Paralegal program. Twenty-four respondents provided comments and suggestions; specifically, respondents provided positive comments including appreciation for the faculty and the program (13 students). Other comments included the need for additional classes/instructors (6 students), frustration with faculty/teaching methods (3 students), requests for assistance with internships (2 students), and requests for extended/expanded access to Westlaw (2 students). #### **Demographics**

Race/Ethnicity. Of the 66 total respondents, forty-one percent indicated that their ethnicity is Latinx, followed by White Non-Hispanic (27%), multi-ethnicity (9%), African American/Black (8%), Filipinx (3%), Asian (2%) and Middle Eastern (1%). Nine percent of the respondents declined to state their ethnicity.

**Education.** Thirty-nine percent of the respondents indicated that they have some college, followed by a Bachelor's degree (29%), AA/AS degree (19%), and Master's degree (10%). Three percent of the respondents indicated that they are currently enrolled in high school.

<u>Current Enrollment.</u> Just over half of the respondents (52%) indicated that they are currently enrolled as part-time students, while 48% of the respondents indicated that they are enrolled full-time.

#### **Recommendations**

Upon review of the results, the following recommendations should be taken into consideration:

- Consider adding a follow-up question on the reason why some students do not follow the recommended sequence of courses.
- Consider implications of results on how students learned about the program for future marketing and outreach.
- Consider ways to expand satisfaction with placement/internship services.
- Consider options for creating an alumni association.

### **Appendix A: Text of Open-ended Questions**

**Question #15:** Please provide any additional comments or suggestions you may have regarding the Paralegal program.

#### Responses

[Faculty members] are the best instructors!

[Faculty member] is incredibly helpful and I always know I can ask [the faculty member] questions when feeling uncertain.

Family Law 150 course with [faculty member] was a class I would not recommend to anyone that wants to learn. Class had no structure, no feedback & trouble communicating with professor

#### Great program!

I am enjoying the program a lot and I really like the professors I've had so far.

-I kind of feel like there needs to be 2 Legal Writing classes: both taken a semester apart at minimum. I think that would help make sure we know what we're doing. -The Legal Research course deals with WestLaw, but we lose access to it after the class ends. The Library Databases gives us access to NexisUni, but we aren't taught how to use it.

#### Responses

I really enjoy that it is online because I do not live in the area. I also like that because it is online, it is very accommodating to my life schedule. I would like more help finding internships of job placements outside of Los angels [sic] area. There are some put not as many to [sic] far north, for examples Santa Barbara County or in Stanislaus County.

I would like more time in Class to review the Chapters. It would be nice to have the option to have a study group with the Professor maybe once a week to ask questions. But in order for it to be fruitful, there would need to be a minimum number of people or the Professor would not conduct a study group.

I would like to see more available counselors to guide you through the program like what classes to take and what else I would need.

If possible, implementing legal internships for students who specifically attend COC would be very helpful.

It seems to be a struggle to get into classes. Having a greater availability or reducing classes to 8 weeks, allowing for more class availability per semester, would be extremely beneficial in keeping students on track to graduate in 2 years. As it stands, I may have to prolong graduation because of class availability.

It would be helpful to have more classes (or available seats in classes) needed in interim semesters such as Winter and Summer that is needed in the recommended structure of courses and their specific order intended courses for this degree are set in. Classes fill extremely quickly and unfortunately makes it hard to follow in the order and sequence they should be taken.

My professors have been amazing, and they care about students success. But particularly adjunct faculty should be monitored as there might be some that aren't able to keep up with organization and grading in their courses. Most faculty are wonderful at COC!

Overall, I am very satisfied with the program. [Faculty members] are wonderful! However, a second Family Law professor would be great.

Please have more than a single professor teach [specific] classes so that students have more options when registering for paralegal courses, especially required ones. I am not satisfied with either the teaching or organization of the current instructor and this will negatively affect my ability to complete my paralegal certificate at COC.

#### Responses

Students could benefit greatly from expanded access to Westlaw. Now, we only have access for the legal research class. It would help us greatly to have another term (at least) in which we could get used to using Westlaw.

The fact that College of the Canyons offers to sponsor the students so that they may attend paralegal conferences, such as the ones offered by the LAPA organization, are very helpful and appreciated.

The Paralegal program at COC is amazing. For the most part, the professors are all amazing and genuinely care about their students. Additionally, they are all highly qualified and knowledgeable in their fields.

The professors and the dean are incredibly helpful; there are no words to describe their assistance.
