#### **3.1 Action: 2025-2026 ASG Budget Drafting Session**

**Background:** In preparation for the ASG grants deliberations that will be taking place on May 6, 2026, instructions will be provided on reviewing grant applications and scoring.

Information was sent to the board that included a link to the applications

An asterisk next to the club/program name includes a video submission.

Scoring sheet is reviewed and explained (tiered ranking).

Deadline to review applicants and complete the scoring sheet is May 1<sup>st</sup>.

Once the grants have been reviewed, an updated list of ICC points clubs have earned will be provided to the board.

Clubs that do not earn enough ICC points will not be awarded grants, even if they are awarded by ASG.

At the next meeting, a breakdown of the score ranking will be provided and discussed.

Clubs may submit only one application.

If any officers are a part of a club that has submitted a grant, that officer should abstain from ranking said club.

Acceptable expenditures and unacceptable expenditures are reviewed in the grant application.

Funds should benefit more than just one student.
