**Background:** American Sign Language Club was placed on probation for failing to meet the minimum Inter Club Council Meeting attendance in Spring 2024. The probationary period will end on December 14, 2024. American Sign Language Club would like to make a case to change the club status to be in good standing and ask to be removed from probation.

Probation Penalties:

- Club funds are frozen except for payment of outstanding debts.
- Use of all campus facilities except for designated meeting rooms is forfeited.
- A club on probation is ineligible for A.S.G. Matching Funds and is ineligible to submit a budget request for the A.S.G. annual grants process.
- A club on probation may not vote on Inter Club Council matters.
- A club on probation is ineligible to earn Inter Club Council incentive points.

The club was put into action in October of this year and 12 members are interested in becoming a member of this club.

During Covid, Sign Language fell off the grid as it was very difficult to hold this type of class over zoom.

The highest level of Sign Language is currently at 103 due to the lasting effects from Covid.
