### LOCKER PROGRAM AGREEMENT

To participate in the MESA Locker Program, I agree to adhere and abide the following terms and conditions:

                     **Initial**  
 I understand that the use of a student locker is a privilege and that lockers are the property of the College of the Canyons MESA Program. At no time does MESA relinquish its exclusive control of the lockers provided for the convenience of students.

                     I understand that I am only allowed to have **ONE** locker and that I am the only one who is authorized to use the locker assigned to me.

                     I understand that I am responsible for the safekeeping of the locker key and will return it to MESA by the date indicated.

                     I understand that the College of the Canyons MESA Program will not be held liable for the contents and personal property stored in the locker and will **NOT** replace or compensate me if the contents are stolen, destroyed, or damaged, regardless of circumstances. I am storing personal items at my own risk. Any items stored in a locker will be considered the property of the student to whom the locker is assigned. I will exercise caution in storing items of value, such as purses, wallets, laptops, cameras, mobile phones or music players. I will lock and secure the locker assigned to me. I realize that contents of an unsecured locker is not the responsibility of the College of the Canyons MESA Program.

                     I understand that the storage of illegal and hazardous materials is prohibited. Storage of such materials will result in disciplinary action.

                     I understand that authorized College of the Canyons and/or MESA personnel reserve the right to inspect the interior of lockers for any reason at any time, without notice, without student consent, and without a search warrant. The locker is campus property and may be inspected if there is reasonable suspicion that the search will uncover evidence of a violation of law or a violation of the College of the Canyons' standard of student conduct.

                     I understand that I have access to the locker only when the MESA Study Center is open for the selected semester. My personal belongings must be removed no later than the return date indicated on this agreement. If my items are not removed by the return date, I authorize MESA to open the locker and dispose of materials found in the locker. MESA is not responsible for any items subject to removal from a locker.

                     I understand that use of a locker will be forfeited upon withdrawal from College of the Canyons or from the MESA Program.

By signing this agreement, I agree to all the terms and conditions for the use of a student locker as required by MESA. I understand that if I fail to comply with the terms of this agreement, I will lose locker privileges and disciplinary action may follow.
