This program has existed outside of the curriculum process and it has gotten to be of a size that tracking has become difficult. In 2014, COC was one of the first community colleges to sign an MOU with then 6 (now 8) law schools to create a series of courses that lay a strong foundation for students to continue their studies in law at the university level and eventually law school. We have approximately 150 students who have expressed an interest in the program. Thus far we have 33 students complete the program.
