 - Emergency Blanket Distance Learning Addendum for Summer and Fall was approved by the Senate on Monday, April 26. Going forward faculty have to plan to add either Permanent or Provisional DLA'S to the courses, they have scheduled for Summer and Fall 2020. The “plan” is submitted with the blanket addendum, we implement the “plan” to apply the DLA’s.
 - Permanent DLA’s. All lecture units can be handled on consent, also courses with lab units currently taught via a distance education modality can be handled on consent. Courses with lab units currently taught face-to-face with instructor supervision of skill development and attainment will require either a Presentation or narrative regarding how digital/distance education modality will be employed, or possibly both.
 - Provisional DLA language being developed as is the process for implementation of said DLA. The Curriculum Committee will finalize both at the May 14th Curriculum Committee meeting.
