Welcome to everyone, especially Mitjl Capet. This was his first meeting with the COC Senate.

**The consent calendar was approved**, which included the summaries for Curriculum and Senate meetings.

#### **General updates:**

**Prerequisites**- we have a date set for our first meeting. If you are interested in attending let Michael or Lita know.

**Equivalencies** – have not met yet. Sherrill Pennington will report on this committee after they have met.

**Institutional Review Board** –October 19<sup>th</sup> will be their first meeting.

- There was discussion on Learning Objectives. The phrase "Culture of Evidence" is found throughout the community college system. Motivated by accreditation, we will need to have "learning objectives" for all parts of the campus. In short, we know what we are doing, but now we will be asked to show evidence of what we are doing. This will require us to maintain a range of different forms of "evidence", including meeting minutes, to support our claims of the wonderful things being accomplished here at COC. There is some concern over where this mountain of memos, minutes, etc. will be housed.
- The topic of Political Speech in the classroom was discussed by Mitjl Capet. Instructors need to be cautious about their classroom discussion of political issues. Such discussion is acceptable, as long as all views are provided equal time without coercion. Instructors should not wear buttons promoting a particular issue including Measure M while on duty in the classroom. There is a video produced to encourage students to register to vote this is acceptable to show in a classroom situation since its goal is to encourage voter participation, as well as to provide general information.
- **Promotion of Measure M** outside of the classroom: If asked, instructors may direct students to the Measure M website for additional information. The website also includes suggestions for those who would like to support the measure, including the ability to endorse the measure via e-mail. However, any individual who endorses via e-mail should NOT use their COC computers.
