This is a synopsis of a few key items that impact community colleges. Please check with Dr. Capet for a more detailed list of new legislation that impacts community colleges.

COMMUNITY COLLEGES

AB 1559. (Nursing)

AB 1559 authorizes the use of a multi-criteria screening process for evaluating candidates for admission to a community college nursing program. A community college electing to use the multi-criteria screening process must consider all of the following:

- * Academic degrees or diplomas, or relevant certificates, held by the applicant.
- * Grade-point average in relevant course work.
- * Any relevant work or volunteer experience.
- * Life experiences or special circumstances of an applicant, including disabilities, low family income, first generation of family to attend college, need to work, disadvantaged social or educational environment, difficult personal and family situations or circumstances, and refugee or veteran status.
- * Proficiency or advanced level coursework in languages other than English, including American Sign Language, Arabic, Chinese, Farsi, Russian, Spanish, Tag-a-log, and various languages of the Indian subcontinent and Southeast Asia.

The community college may also, but is not required to, use additional criteria such as a personal interview, a personal statement, letters of recommendation, the number of repetitions of prerequisite classes, or other criteria approved by the chancellor.

SB 139. (Nursing)

SB 139 adds a provision that prohibits any campus of the California State University or the California Community Colleges that operates a registered nursing program from requiring a student to complete general education requirements when the student has already earned a baccalaureate or higher degree from a regionally accredited institution of higher education. Instead, the student need only complete the coursework necessary for licensing as a registered nurse.

SB 139 authorizes any college, university or other entity that operates an accredited registered nursing program to require a prospective student to provide criminal record clearance prior to enrollment.

SB 139 makes a person who has earned a baccalaureate or graduate level degree and who meets other requirements of the State Nursing Assumption Program of Loans for Education (SNAPLE), eligible to enter into a loan assumption agreement under the program. It also makes a person who is currently employed as a registered nurse in a state-operated 24-hour facility ineligible to enter into a loan assumption agreement under the program.

Existing law grants to the Board of Governors and the Chancellor the authority to award grants to community college districts with associate degree nursing program for the purpose of expanding enrollment and reducing program attrition. It also authorizes a community college district, whether or not it participates in the program, to use multi-criteria screening measures for admitting students to the nursing program. It also prohibits a community college district from excluding an applicant from the registered nursing program on the sole basis that the applicant is not a resident of the district or has not completed prerequisite courses for that district.

SB 166 (Emergency Planning)

SB 166 requires the Office of the Chancellor of the California Community Colleges, in consultation with the Governor's Office of Emergency Services and the Office of Homeland Security, to develop emergency preparedness standards and guidelines for community college districts and campuses in the event of a natural disaster, terrorist activity, or hazardous condition. These standards and guidelines must be developed by January 1, 2009.

AB 668 (Increase Pell Grants)

AB 668 enacts the California Community College Student Federal and State Financial Aid Opportunity Act with the express intent of the Legislature to increase the number of students of the California Community Colleges receiving federal Pell Grant awards. It also requires the Chancellor's Office of the California Community Colleges to inform students of the opportunities to participate in the federal Pell Grant Program.

AB 1540 ("Cash for College" program)

AB 1540 establishes the Cash for College Program under the administration of the Student Aid Commission and authorizes the commission to allocate funds for support of local programs. It further creates the Cash for College Fund and appropriates voluntary contributions or donations into the fund for the program's purposes. In addition, the bill expresses the intent of the Legislature to inform California students with financial need of the various state and federal financial aid programs.

AB 1323. (TB tests for employees)

Existing law requires an intra-dermal tuberculin test for employment in a community college district. AB 1323 would authorize the test for tuberculosis to be done by any tuberculin test recommended by the federal Centers for Disease Control and Prevention (CDC) and licensed by the federal Food and Drug Administration (FDA).

AB 1548. (College Textbook Transparency Act)

AB 1548, the College Textbook Transparency Act, requires publishers for all textbooks published on or after January 1, 2010, to print on the outer cover of, or within, the textbook a summary of the substantive content differences between the new edition and the prior edition of the book.

AB 1548 prohibits an "adopter" of an institution of higher education from demanding or receiving anything of value for adopting specific course materials required for coursework or instruction. An "adopter" means any faculty member or academic department at an institution of higher education responsible for considering and choosing course material.

AB 1548 prohibits a publisher or campus bookstore from soliciting faculty for the purpose of the sale of instructor copies or complimentary teacher editions of textbooks which have been provided by a publisher at no charge. It also requires that, for new editions published on or after January 1, 2010, the exterior of an instructor or complimentary copy textbook must note on its exterior that it is an instructor's copy and not for resale.

SB 272. (Priority registration for Armed Services members)

SB 272 requires the California State University and each community college district, to give any member or former member of the Armed Forces of the United States who left active duty within the past two (2) years), priority for registration for enrollment on any campus within their jurisdiction that administers a priority enrollment system. This includes students already enrolled in the institution who were called to active military duty and took an academic leave of absence. SB 272 also provides that, if the Commission on State Mandates determines that SB 272 contains costs mandated by the state, reimbursement of the costs will be made according to the procedures established by statute for those reimbursements.

SB 854 (Voter Registration with class registration)

SB 854 requires every community college and California State University campus that operates an automated class registration system on or before January 1, 2008, to permit students to coordinate with the Secretary of State during the class registration process to receive voter registration information.

The bill further provides that, for community colleges and California State University campuses that do not operate an automated class registration system on or before January 1, 2008, they may implement an automated voter registration system within two years of when they begin to operate an automated class registration system. The bill also encourages the University of California to do the same.

SB 854 requires every high school, community college, and California State University campus to designate a contact person to be contacted by the Secretary of State for the distribution of voter registration cards.

Stand Alone courses will now be identified on the agenda (in the same way that New and Modified Prerequisites and Distance Learning Addendums are highlighted) so that the committee is aware they are potentially approving a stand-alone course. And on that note, the Music department will be revising MUSIC 080, 081 and 082 (Santa Clarita Valley Youth Orchestra) to be sure these courses are in line with the college's mission.

The committee also discussed the need for a boilerplate for like courses that cross disciplines (i.e.: 090L) so that we are consisted with how they are offered (if possible).

There is also a movement toward removing high school preparation as an option to enter COC advanced foreign language courses. As SPAN 201 and 202 came before the committee, any mention of prior high school Spanish course completion was removed from the pre-requisite.

The committee talked about how high school foreign language content is difficult to verify, and we will apply this same approach to COC advanced French and German courses when they come through Curriculum in the future.

The committee recognized Deanna's dedication to the Curriculum review process as she chaired this, her last meeting. Deanna will be coming to the next few Curriculum meetings to assist Ann Lowe as she transitions into her role as the new co-chair.
