Academic Senate Summary October 8, 2009

The consent calendar was approved, which included summaries for Senate September 10 & September 24, 2009; Curriculum summary for September 17, 2009; confirmation of Tina Waller as representative for Allied Health; and moving the status of the Sustainable Development Committee from "ad hoc" to "regular".

In the CCC report, Fred **D'Astoli**, reported on the CCC for a Star Party on October 23, 2009. Other CCC items:

- FTES is up 18%; down 11% in number of sections from fall 2008; up 12% in headcount over fall 2008;
- the Foundation Resource Council met at CCC for the first time on 9/24/09 when it toured ECE CDC;
- hand washing/cleansing stations installed in high traffic areas for health and wellness;
- reprographic services doing well with many faculty are making use of the services.

Grades and Attendance subcommittee has nothing to report at this time.

Program Review updates were reviewed by Miriam Golbert. These items included:

- Changed software
- Expand boxes
- Greater editing ability
- Larger Font
- Landscape orientation
- Greater connection to the budget

- Asking # of times a course has been offered
- "weakness" changed to "challenges"
- Expand field to 100 to 200 words
- Annual review as "read only" for faculty members
- Year to year data

Honors Program, again according to Miriam Golbert, is doing great. Tremendous student response has led to an increase demand for specific Honors courses as well as a two-year program.

Proposed Minimum Qual changes for "non-masters" discipline, was discussed by the Senate. This is a topic that those disciplines using a non-Masters MQ should be up to speed on. In short, the proposal would decree that there is NO equivalency available for an AA degree.

Website focus group was reported on by Jasmine Ruys. Overall there was student satisfaction with our Website – however, there is still a demand for a more effective "search" function. A synopsis of the report is available on the Senate Website; contact Jasmine for a full report.

Revisions (Policy and Procedures: Concurrent Enrollment Policy/Procedure) were approved by the Senate.

The use of the placement test as a "entrance exam" for concurrent enrollment was removed (although students must still participate in the placement/testing process)

Minimum Quals for CWEE was discussed by Stan Wright. The consensus was that we should have a "Readiness Checklist" for CWEE, similar to the "On-Line Instructor Readiness Checklist". Stan will prepare and bring forward a proposed checklist for further discussion.

The Computer Log-in Statement, which was to be implemented in 2002, has finally been implemented. This is mandated by Board Policy 815. Check with Jim Temple for additional insight and information. Adjourned at 4:10.
