- **The consent calendar was approved**, which included Academic Senate summaries for March 25, 2010 and April 15, 2010; the Curriculum summaries for April 1, 2010 and April 15, 2010; and the confirmation of Senate Elections for Edel Alonso as President and David Andrus as Vice President.
- The Senate ratified the establishment of "Clinical" for new courses, adding to the current choices of "lecture" and "lab".
- **The Principle of Rotation**, in relation to department chairs, was discussed. After great research oit was agreed that, using the "principle of rotation", in a tied departmental chair ele3ction the individual who has not served as department chair would be given the position. Disclosing Financial Interests Relevant to Federally Sponsored Projects

I. PURPOSE & SCOPE

Federal regulations require Investigators to disclose certain financial interests (as defined below) to ensure that the design, conduct or reporting of federally-funded projects will not be biased. Each grantee institution is required to maintain an appropriate written and enforced policy on conflict of interest and that all conflicts of interest for each award be managed, reduced or eliminated prior to the expenditure of the award funds. If the institution carries out agency-funded projects through subawardees, contractors or collaborators, the Institution must take reasonable steps to ensure that:

- a) The entity has its own policies in place that meet the requirements of this policy; or
- b) Investigators working for such entities follow the policies of the primary institution.

This policy describes the conditions under which these financial interests should be disclosed by Investigators, regardless of whether the Investigator is a Santa Clarita Community College District (SCCCD) employee or not. The procedure is applicable to all sponsored projects and educational activities supported by the National Science Foundation (NSF) and other federal agencies, and by other sponsors and programs that specifically request review consistent with federal regulations on objectivity in sponsored projects.

Each Investigator is required to disclose all significant financial interests of themselves, their spouse and dependent children that:

- (i) would reasonably appear to be affected by the sponsored projects or educational activities funded or proposed for funding; or
- (ii) in entities whose financial interests would reasonably appear to be affected by such activities.

Financial interests disclosed by SCCCD Investigators are reviewed by the Chief Business Officer (CBO). The CBO will determine whether a conflict of interest exists, and determine what conditions or restrictions, if any, should be imposed by the institution to manage, reduce or eliminate such a conflict of interest. A conflict of interest exists when the reviewer (CBO) reasonably determines that a significant financial interest could directly and significantly affect the design, conduct, or reporting of Federally-funded projects and educational activities.

Examples of conditions or restrictions that might be imposed to manage, reduce or eliminate conflicts of interest include, but are not limited to:

- a. public disclosure of significant financial interests;
- b. monitoring of project by independent reviewers;
- c. modification of the project plan;
- d. disqualification from participation in the portion of the Federally-funded project that would be affected by significant financial interests;
- e. divestiture of significant financial interests; or
- f. severance of relationships that create conflicts.

If the reviewer determines that imposing conditions or restrictions would be either ineffective or inequitable, and that the potential negative impacts that may arise from a significant financial interest are outweighed by interests of scientific progress, technology transfer, or the public health and welfare, then the reviewer may allow the research to go forward without imposing such conditions or restrictions.

II. DEFINITIONS

Investigator: For purposes of this procedure, Investigator means any individual who shares responsibility for the design, conduct or reporting of the results of a sponsored project with the Principal Investigator.

Principal Investigator (PI): An Investigator (normally an academic appointee) who has primary responsibility for the scientific and technical conduct, reporting, fiscal and programmatic administration of a sponsored project.

Significant Financial Interest: Anything of monetary value, including, but not limited to, salary or other payments for services (e.g. consulting fees or honoraria); equity interest (e.g. stocks, stock options or other ownership interests); and intellectual property rights (e.g., patents, copyrights and royalties from such rights).

The term does not include:

- a. salary, royalties, or other remuneration from the applicant institution;
- b. any ownership interests in the institution, if the institution is an applicant under the Small Business Innovation Research Program or Small Business Technology Transfer Program;
- c. income from seminars, lectures, or teaching engagements sponsored by public or non-profit entities;
- d. income from service on advisory committees or review panels for public or nonprofit entities;
- e. an equity interest that, when aggregated for the investigator and the investigator's spouse and dependent children, meets both of the following tests; (i) does not exceed \$10,000 in value as determined through reference to public prices or other reasonable measures of fair market value; and (ii) does not represent more than a 5% ownership interest in any single entity; or
- f. salary, royalties or other payments that, when aggregated for the investigator and the investigator's spouse and dependent children, are not expected to exceed \$10,000 during the twelve-month period.

III. DISCLOSURE OF SIGNIFICANT FINANCIAL INTERESTS

Investigators are required to disclose Significant Financial Interests as defined below. In all cases, reporting is required for the individual, his/her spouse or registered domestic partner, and any dependent children.

Disclosure of Financial Interests will be reviewed by the CBO to determine whether they reasonably appear to directly and materially affect the design, conduct or reporting of projects and thereby constitute a conflict of interest that may need to be managed, reduced or eliminated. If the Institution finds that it is unable to satisfactorily manage a conflict of interest, the CBO will notify the funding agent.

A. Significant Financial Interests That Must be Disclosed

All Investigators must disclose:

- Any Significant Financial Interests that would reasonably appear to be affected by the sponsored project for which funding is sought; and/or
- Any Significant Financial Interests in entities whose financial interests (e.g., its earnings, value, sales of its products, etc.) would reasonably appear to be affected by the sponsored project.

B. Who Must Disclose Significant Financial Interests

- All SCCCD of the Canyons Investigators who share responsibility for the design, conduct or reporting of the sponsored project results must disclose Significant Financial Interests to SCCCD.
- Collaborators from other institutions who share responsibility for the design, conduct or reporting of project results, and who will be conducting services under a sub-grant or subcontract from SCCCD are expected to comply with the policies and procedures for disclosure and review of any Significant Financial Interest at the institution at which they are employed. Those institutions are responsible for reviewing those disclosures and, if conflicts are identified, for sending SCCCD of the Canyons assurances of their ability to manage, reduce or eliminate the conflicts.

• Collaborators who share responsibility for the design, conduct, and reporting of project results, and who will participate in the sponsored project under an independent consulting agreement issued by SCCCD should be identified as Investigators by the SCCCD PI and should complete the SCCCD of the Canyons disclosure forms. If, upon review, SCCCD determines that these financial interests could directly and significantly affect the design, conduct, or reporting of the project to be performed under the agreement, consultants will be expected to adhere to the plans put in place to eliminate, reduce or manage the identified conflicts of interest.

C. When Must Disclosures be Made

Disclosures of Significant Financial Interests must be made:

- Each time a request for new funds is submitted to any federal agency;
- Each time a request for support is submitted to another sponsored program that requires review under federal regulations;
- Any time a new Investigator is added to the project; and
- Any time during the term of an ongoing award that an Investigator has a change in a reportable Significant Financial Interest or acquires a new Significant Financial Interest that was not reported on the original disclosure form.

Examples of situations in which Significant Financial Interests should be disclosed include, but are not limited to:

- An Investigator is conducting a sponsored project where the results could be relevant to the development, manufacturing or improvement of the products or services of an entity in which the Investigator has a Significant Financial Interest.
- An Investigator has a Significant Financial Interest in an entity which might manufacture or commercialize a drug, device or procedure that might result from the sponsored project; or which manufactures or sells any product that will be tested or used in the sponsored project, or that would reasonably appear to be affected by the project.
- An Investigator has a Significant Financial Interest in an entity which manufactures or sells a concomitant or comparator drug, device, or procedure and would reasonably appear to be affected by the project.
- An Investigator received consulting income that exceeded \$10,000 from any entity during the prior 12 months or anticipates receiving income of \$10,000 or more over the next 12 months, and the financial interests of that entity would reasonably appear to be affected by the project.
- An Investigator has a Significant Financial Interest in an entity to which a portion of the work under the project will be subcontracted, from which space will be leased, to which participants will be referred, or from which purchases will be made.
- An Investigator is carrying out a sponsored project and has a Significant Financial Interest in an entity that is part of a consortium or that will otherwise participate in the sponsored project.

In accordance with federal regulations, all disclosures must be received by the Business Office *before* the application for funding is submitted to any federal agency. All reviews must be completed and, if required by sponsor policy, notification provided to funding agent before the funds can be expended. Financial disclosures will be updated during the period of the award on an annual basis, when a new investigator is added to the project or as new reportable significant financial interests are obtained.

D. Record Retention

The Institution will maintain records of all financial disclosures and of all actions taken to resolve conflicts of interest for at least three years beyond the termination or completion of the grant to which they relate, or until the resolution of any action by the sponsor involving those records, whichever is longer. Records relating to unfunded projects need not be retained. The information provided in disclosure forms may be released or transmitted to the sponsor upon request.

E. Sanctions

Failure of an individual to file a complete and truthful financial disclosure for pending proposals, or when a new interest is obtained, or failure to comply with any conditions or restrictions directed or imposed, including failure to cooperate with appointed project monitoring bodies, will be grounds for discipline. Agreements with consultants who either fail to file a complete disclosure or fail to comply with any conditions or restrictions imposed may be terminated for cause. In addition, federal regulations may require reports to the federal sponsor of any violations of federal regulations and SCCCD policy. If an Investigator's failure to comply with this policy has biased the design, conduct, or reporting of federally supported project, the CBO will promptly notify the appropriate agency of the corrective action taken or to be taken.

Application for Flex Credit

-> <u>This application is for professional development activities not already on the Flex schedule</u>. You must submit this application to request flex credit for an activity prior to the activity taking place.

Deadlines

- Applications for <u>conferences</u> and <u>off-campus training</u> must be submitted at least five days before the activity.
- Applications for <u>independent flex projects</u> must be submitted by the Friday of the sixth week of the semester.
- Applications for independent flex projects to be completed during the summer should be submitted by May 15.

In order to be approved, the activity must meet <u>all</u> of the following criteria:

- The primary goal of the activity must be professional growth and achievement of the mission of the college, its vision, and the mission of professional development in staff improvement, student improvement, or instructional improvement.
- Accomplishment of the activity must be of sufficient benefit to justify the time spent.
- The activity must be designed to foster an analytical or reflective approach to professional development.
- You must not be compensated in any other way for this activity.
- The majority of the event must not be recreational or social.
- The activity must fall outside expected departmental and other contractual faculty duties.

Check one of the following:

_____This is an application for flex credit for attending a <u>conference</u>. Answer questions one and two below (only). Flex credit for attending conferences is limited to 20.5 hours a year.

_____This is an application for flex credit for attending <u>off-campus training</u> conducted by a non-COC training provider. Answer questions one and two below (only).

_____This is an application for flex credit for completing an <u>independent flex project</u>, which is a professional development activity that is conceived and executed by a faculty person independently of any training provider or organization. Answer all questions below. Also, submit the final project to the Professional Development Director by June 30th. The final project must include the measurable product, which will be posted on the Professional Development website. Flex credit for an independent flex project is limited to 20.5 hours a year.

Please be as thorough as possible. If vague information is provided, a response to your application may be delayed.

- 1. Provide a 4-5 sentence description of the activity.
- 2. State the learning outcomes for the activity and explain how participants will meet them.
- 3. Describe the <u>measurable product</u> that will result from the **independent flex project** and provide a <u>timetable with benchmarks for completion of the product</u>.
- 4. Describe how you will disseminate and share (as appropriate) the product of your **independent flex project** with your colleagues so as to support the mission of the college. Consult the Professional Development Director if you need advice about the most appropriate way to do this.

Examples of Activities that <u>Do</u> Meet the Flex Criteria

- Faculty- or staff –led workshops or presentations given to faculty to provide them with tools to improve student learning.
- Faculty- or staff –led workshops or presentations given to faculty to inform them about student services available at COC.
- Faculty- or staff –led workshops or presentations given to faculty about topics concerning cultural diversity.
- Faculty- or staff –led workshops or presentations given to faculty about topics concerning human resources.
- Faculty- or staff –led workshops or presentations given to faculty about topics concerning institutional effectiveness.
- Faculty- or staff –led workshops or presentations given to faculty about topics concerning employee health and wellness.
- Faculty- or staff –led workshops or presentations given to faculty about topics concerning the college's financial stability.
- Faculty- or staff –led workshops or presentations given to faculty about topics concerning technological advancement.

- Faculty- or staff –led training sessions focused on how to use computer resources that will be utilized during instruction. If this training is publisher-provided, its goal must be to train participants in using the resources, not merely to display the product for sales purposes. All publisher-led training is limited to 4 hours per academic year.
- Lectures or talks that enrich a faculty person's knowledge of other disciplines and areas of knowledge.
- Research or travel to non-local sites to develop materials for a new course or program.
- Faculty-led trips to museums or other cultural sites that enrich a faculty person's knowledge of other disciplines and other cultures.
- General training in web-page creation.

Examples of Activities that **Do Not** Meet the Flex Criteria

- Workshops or presentations given to students or student groups to improve their learning. While these activities do support the mission of the college to improve student learning, they do not provide professional development with an analytical or reflective approach. They also fall within the stated duties of a faculty position: "Advises, assists, evaluates and mentors students."
- Social gatherings of colleagues, including parties, receptions, celebrations, and recreational films. If an event includes both a reception and a lecture or talk, the lecture or talk portion may receive Flex credit while the reception portion does not. You may be asked to designate how much time is going to be socially-focused if you are proposing a mixed event. Film showings must include a substantial discussion period with focused questions.
- Publisher-led presentations of textbooks and ancillary materials, including websites and software, designed to help faculty decide whether or not to adopt the materials.
- Activities that fall within the expected preparation work for teaching a course, including orientations required by companies or organizations where you will be performing work/duties as part of a COC course that you will be teaching (i.e.: hospital orientations if you teach in the Nursing Department) and training to

maintain current in your subject matter (i.e.: computer software upgrades if you teach in the CIT Department).

- Certification tests required of you to maintain your status as a faculty member in your discipline (i.e.: mechanic certifications if you teach in the Automotive Department).
- Regular revisions of curriculum and creation of new courses. If the work to prepare new curriculum does go far beyond the normal expected amount, you may propose an individual Flex project, but it must meet the Flex criteria.
- The development of individual/department web sites.
- Informal or unfocused time spent with faculty colleagues in discussions about one's subject matter or area of specialization. An independent Flex project must include a measurable product that will result.
- Organizing events, including public relations, communications, shopping (for supplies) and other administrative or organizational tasks.

Proposal: Statement and Policy on Academic Integrity and Plagiarism

Proposed by Academic Integrity Subcommittee:

Jia-Yi Cheng-Levine (contact), Michael Joslin, Jennifer Brezina, Jose Martin, and Fred D'Astoli The following statement, if passed/agreed by the senate, will be proposed to be included in the Students Handbook, the Faculty Handbook, the Schedule of Class, the next Catalog, on the college's website, and possibly on the cover of the blue books sold on campus.

Statement on Academic Integrity at College of the Canyons

Students are expected to do their own work as assigned. At College of the Canyons, we believe that academic integrity and honesty are some of the most important qualities college students need to develop and maintain. To facilitate a culture of academic integrity, College of the Canyons has defined plagiarism and academic dishonesty. Due process procedures have been established when plagiarism or academic dishonesty is suspected.

At COC, we define plagiarism as follows: Plagiarism is the submission of someone else's work or ideas as one's own, without adequate attribution. When a student submits work for a class assignment that includes the words, ideas or data of others, without acknowledging the source of the information through complete, accurate, and specific references, plagiarism is involved. This may include dual submissions of a similar work for credit for more than one class, without the instructor's knowledge and approval.

To be specific, below are some of the situations that will be considered plagiarism at COC:

- Use information from any source, online or in print, in one's own writing *without* acknowledging the source in the content <u>and</u> in the reference page of the assignment;
- Simply list the sources in the reference page, without parenthetical citations in the body of the essay;
- Take more than one printed line of words consecutively from the source without putting quotation marks around them, even though the student has put the author's name in the parentheses or in the reference page;
- Turn in work done for other classes, regardless how big or small the assignment may be, without the instructor's approval—this is considered "self-plagiarism," which is a form of academic dishonesty; or,
- Turn in work by another student, even by accident.

In addition, COC has strict rules against using electronic devices during exams without the instructor's approval. To be specific, absolutely no cell phones or any electronic devices can be on the desk or in sight during test or exam without the instructor's approval. The presence of electronic devices in sight during exams may be considered as intention to cheat and will be processed as a form of academic dishonesty.

Cases of alleged academic dishonesty, such as plagiarism or cheating, will be referred to the Dean of Student Services for investigation. See your syllabus for course specific policies, rules, and guidelines on plagiarism and academic dishonesty.
