1. Call to order: 3:03 pm

- 2. Public Comment:
 - There was a request to start a dialogue regarding how faculty can best deal with student athletes missing class for scheduled athletic events. Issue should be addressed in a professional, respectable and equitable manner. This topic may be brought back as a separate discussion item.

3. Approval of the Agenda

- Request to modify the agenda, moving item "Program Viability Evaluation Rubric:

 Unanimous. Approved.
- on the May 16, 2019 Curriculum Committee summary, a course which had been in tech review, was inadvertently omitted from the consent calendar. Lisa presented and shared a new summary with the addition of this course. It was clarified that these revisions are non-substantive and are automatically added to the consent calendar. The course was originally agendized on April 18th but the faculty member wasn't able to complete the revisions. If this course does not go through the process, as it is scheduled for the fall, it will not be available in the fall semester. The course is **ARCHT-200B**-Architecture. The revised summary was submitted to Marilyn. Lisa Hooper, Curriculum Committee chair stated that all Curriculum Committee members are in agreement with this revision. The description of this Action was as follows:
 - Units increased to 3 units (formerly 1 unit). Revised SLO, revised objectives and content. Recommended preparation of ID-103 changed to ARCHT-190.

1. President Report, Rebecca Eikey

- President gave thanks to the Academic Senate for a wonderful year and for all that was accomplished. Certificates of Appreciation where presented for the following senators for serving on the Academic Senate:

- 2. College Planning Team Committee Report, Claudia Acosta
 - The committee meets once a month, on the 3rd Monday of the month. Last meeting of the semester took place on May 20th. The committee met in January to plan a Planning Retreat and to discuss how to best connect with the community and overall partnerships. There was also a proposal to do a Planning Summit in the fall. This summit will help to create a dialogue and motivate people. There will be further discussion on the Committees on Committees. The hope is that every committee provides an evaluation or an annual report summary.
 - CPT oversees the planning efforts of the college district and evaluates the college effectiveness. The focus of CPT is to promote innovation and identify issues and trends that will impact what the college does. CPT receives a lot of input and updates from other planning committees such as Guided Pathways Initiative, Local Goal Settings, Student Equity & Achievement, Strategic Planning, Civic Engagement, ISP, Enrollment Management and IE2. CPT has developed a template form which is filled out by anyone who requests to present a report. This form helps to orient all the request which come through. CPT also reviews research reports and action implication to ensure that the college's strategic plans are carried out.
- 3. COC Speech Team National Tournament winner student Jaylon Kirk & faculty Michael Leach
 - Michael Leach introduced student Jaylon Kirk, a student in his speech class. It was
 emphasized that one of the most underrepresented groups in the Speech community
 are those with disabilities. Jaylon was in the final round of Pros, one of the most
 competitive and heavily entered national tournament events. A professional actress by
 the name of Valerie, with 20 years of acting and writing experience, was on staff this
 semester. Valerie emphasized the importance of letting students tell their stories in
 their own words.
 - Student Jaylon Kirk shared his story through a speech which he presented to the Senate. The student was able to develop his speech in the COMS 100. The course is part of the Communications Department and is 3-4 units which can be repeated.
- 4. Policy Review Committee, David Andrus
 - David shared his Policy Review Committee yearly report. The committee met and
 discussed how it can become more efficient. The committee functions on a practical
 rather than a theoretical approach and mostly makes recommendations but has held
 votes in the past when needed. Unanimous recommendations may be forwarded to the
 Academic Senate. The Policy Committee receives policies from different members of
 administration on campus. All Academic Policies (AP's) and Broad Policies (BP's) go
 through CPC. BP's have to be approved by the Board and AP's do not. For example a

- recent Academic Freedom policy was first approved by Senate, was then forwarded to College Policy Council (CPC) and is now back in Policy Committee
- David shared a list of policies which were cleared by Senate and a list of documents in committee, including AP 7120A Faculty Recruitment, which may be broken out into separate procedures. Lastly, the Appendix H, a flow chart on how policies move throughout the campus, was shared. David thanked all the committee members for all their work throughout the semester.

C. Action Items

 - The Program Review Prompts where modified last year. This year was the first year of implementation. No new prompts where added only deleted and language was clarified. On pg. 36 the information was replaced with a table.
 - Motion to approve the Program Review edits to the prompts by David Andrus, seconded by Philip Marcellin. Unanimous. Approved.

2. Discipline Memos:

- Additional Discipline Assignment for Brittany Applen (pg. 40-41)
- Britany is meeting the equivalency for Recreation Management. Britany met the
 equivalency back in 2011. There was an error in terms of how HR was counting her
 teaching experience. The experience was being counted under the equivalency that
 would have been valid in 2011. This has now been corrected.
- Motion to approve the additional Discipline Assignment for Brittany Applen by Regina Blasberg, seconded by Sab Matsumoto. Unanimous. Approved.
- 3. Starfish/Canyons Connects recommendations, Collette Gibson & Julianne Johnson (pg. 42-45)
 - Approval of the prompt recommendations will allow for the pilot to be tested over the summer. Julianne will then update the Senate on updates and how it will move forward to the fall semester. The "Flag: Low Scores" prompt phrase "Here are your instructor's comments, if submitted:" will be deleted and the Academic Steps option can also be deleted.
 - Motion to approve the prompt recommendations by Erica Seubert, seconded by Philip Marcellin. Unanimous. Approved.

4. Program Viability Rubric:

- Clinical Lab Science Credit Certificate, (pg. 46-54)
 - This action item is to create a new Credit Certificate of Specialization program for a Clinical Lab Science. Letters of support for Clinical sites where identified.
 This creates an opportunity for MLT student to do another level of technical work in the medical field. This program will be for credit.
 - Motion to inititate this program by Lisa Hooper, seconded by David Andrus.
 Unanimous. Approved.
- Law Enforcement Technologies Associates Degree, (pg. 55-60)
 - This is for the initiation of a new degree program in Law Enforcement
 Technologies. This program may be offered online. This program is for students

- seeking to go into law enforcement related fields but who may not be good candidates for academies.
- Motion to initiate this new program by David Andrus, seconded by Gary Collis.
 Unanimous. Approved.
- Crime and Intelligence Analysis Credit Certificate, (pg. 61-69)
 - This program will be a credit program. This certificate would allow students to work for various federal and local agencies. Students would need to know GIS and computer software. Therefore, the Geology/Geography departments have been in communication regarding sharing computer space.
 - Motion to initiate the new program by David Andrus, seconded by Lisa Hooper.
 Unanimous. Approved.
- 5. Joint Advocacy Letter Regarding Governor's Budget Proposal (pg. 70-73)
 - There was a similar letter approved last year. Budget timeline sheets were passed shared. Rebecca and Wendy attended the local advocacy meeting on Tuesday. One request was to revise the letter so it was more prominent in the need to hire more full-time faculty. One committee recommends \$20 mill in ongoing funds to hire full-time faculty and the other recommends \$40 mill. There is currently \$50 million in this year's budget, ongoing, to hire full-time faculty. If there is \$40 mill for next year then there will be \$90 million. Hiring more full-time faculty will meet the equity marks for the students. It was stated that given that \$20-\$40 million will be
 - There was some concern expressed with the letter stating that "Base Funding allows for the hiring of more full-time faculty...," and that instead it should call attention to the sub-committees stating there are \$20-\$40 mill ongoing for hiring of full-time faculty.
 - COCFA has also put together a letter which will be forwarded to all faculty which could be signed and faxed. In addition, a template letter was created so that anyone could sign and could then be dropped off at Dr. Van Hook's mailbox. The Chancellor's office could then fax those letters.
 - Motion adopt the Joint Advocacy Letter by Wendy Brill, seconded by Aaron Silverman.
 Unanimous. Approved.
- 6. Resolution in Support of Climate Change and Environmental Sustainability, Marco Llaguno & Jason Oliver (pg. 74)
 - The resolutions ask for the Board of Trustees to do change in reducing college's impact on climate change by petitioning for climate friendly food service, such as a food diversion program and some of the elimination of plastics. The impetus was for the students as it will become more important for students to advocate. If this resolution is adopted it would be read and the next board meeting on June 12, 2019.
 - Motion to adopt the resolution by Erica Seubert, seconded by Gary Collis. Unanimous.
 Approved.

D. Discussion

- 1. Zero Textbook Cost (ZTC) & Low Cost Material (LCM) Categories, Teresa Ciardi & Gina Bogna
 - Neither presenter was available for this discussion. This item will return on the next agenda.

- 2. Mapping and General Education Courses & Meta Majors Proposal, Erika Torgeson (pg. 75-84)
 - The students want the Meta Majors to be the schools. When the new COC website goes live the Meta Majors will be on the home page. If schools were to separate or if there is misalignment within a school then subsequent pages will need to be further developed to show the students the information. The suggestion is to model after Pasadena City College. This work will be done by the Deans as the Deans are responsible for dealing with the webpages for the schools. In order for schools to split a conversation needs to take place in Senate as it will affect Senate sub-committees representation. Taglines have not been approved and will not be going live on the website as these are still being explored. Meta Majors are not schools structure. Meta Majors are based on curriculum. Schools are based on administration. It was clarified that Meta Majors are large groups of programs.
 - There was a question in regards to, is it ok for maps to have basic general education headings? Or does the program mapper have to be uploaded with specific GE courses?
 The re-certification of the guided pathways grant for year two allocations, which will occur in year three, will happen in September. COC has been accepted into the second pilot for the program mapper which Bakersfield College is using.
- 3. Academic Calendar 2020-2021, Daylene Meuschke
 - Results of the Academic Calendar 2020-2021 Survey were shared. Students, Faculty, Staff, and Administrators, Full-time and Adjunct faculty were all surveyed. The data demonstrates averages. However, it was clarified that Survey Monkey generated this data and not the Institutional Research Office. The numbers have been reconfigured.
 - Survey Calendar options were:
 - o 1st choice, Calendar Version A: adds a fall break.
 - 2nd choice, Calendar Version B: creates a 6 week winter break and adds a fall break.
 - o 3rd choice, Calendar Version C: Only creates a 6 week winter break.
 - 4th choice, Calendar Version D: status quo (leaving existing calendar as is).
 - Across all of the groups, 2nd choice, Calendar Version B and 3rd choice, Calendar Version C do not come out as a top choice. However, 4st choice, Calendar D does came out as top choice and received the most votes in the student, full-time, adjunct and classified/confidential staff groups. The Classified/Educational Administrators group favored 1st choice, Calendar Version A, coming out as top choice.
 - The Academic Calendar Town Hall meetings discussed topics such as at what length format classes do students succeed best? What is the student population during the day vs night? These ideas where then forwarded the Faculty Calendar Committee. There was a request to revisit these questions and to not change the calendar until these questions are answered along with the data. Due to the Calendar Committee needing a Calendar for 2020/2021 by default the status quo option will be selected.
- 4. Program Viability Evaluation Rubric: Physical Therapist Assistant Program, Sarah Ehrsam
 - The 2017 Advisory Board Meeting for the Sport Medicine program approached the consideration to have COC offer a Physical Therapist Assistance Program. There is a growing need as data from 2017-2020 demonstrated a 25% increase in jobs. This program was presented to the Program Viability Committee in October. There are two deans, Micah Young and Chuck Lyon who are interested in accepting this program into their schools. There is a question of where will this program live best.

This program would be similar to the Nursing program in that it will have an external accrediting agency. All Physical Therapy programs must be accredited by the Commission on Accreditation in Physical Therapy Education (CAPTE). CAPTE mandates a director be hired 18 months prior and a clinical coordinator be hired 9 months prior to offering classes. The program director has to be a part of the curriculum development. Grant funds are available for hiring a program director prior to the program being developed. In terms of CAPTE candidacy accreditation the earliest a class could be offered would be for the fall of 2022. A program director would need to be hired by Feb. 2021. There are only two other locations which offer the PTA program, one is Cerritos College receiving over 350 applicants a year. Several letters of commitment from local business such as Vargo Physical Therapy and Henry Mayo Newhall Hospital are offering their clinics as teaching lab sites. There is still a need for a faculty member to continue to move this through the process, such as a chair of a hiring committee. Without CAPTE accreditation students could not sit for the state licensing exam. Lisa Hooper stated she will bring this program through Academic Staffing and request a program director & clinical coordinator position. This item will return in the fall as an action item.

 - Enrollment Management Meeting: The board is trying to set the budget in thinking about Enrollment Management and how they can cut their own expenses.
 - o COCFA contract was ratified.
 - o Canyons Completes Guided Pathways: Several reports have come through Senate.
 - April 26, 2019 Canyons Complete Calibration Meeting: The group determined there
 may be a need to develop a more comprehensive strategic plan for that work.
 - There may be a need for a Design Team meeting to discuss the Calibration and IE2 meeting and determine what the next steps are.
 - o Governor Meeting- The governor delivered the May revised budget and is available online as a PDF document. Relative to the January proposal, 8 million to the CSU's to address hunger and housing issues which have been expressed. 32 million, one time funds to the UC's, however, much of these funds where for pensions. CCC's have received 80.8 million increase, of which, \$75.2 million will be used for Strong Workforce Funds (SWF) training. Other areas mentioned where Foster Care and College Promise. COLA was reduced. The will also be support and training for Mental Health and increased funding for a Mental Health Hotline. There will also be support for Early Childcare and Early Childhood Education.
- 2. Guided Pathways Report, Erika Torgeson (pg. 32)
 - For a full summary of this report go to (pg. 27)

Special Note: Item #3 was re-ordered due to presenter arriving towards the later part of the meeting.

3. Minimum Qualifications and Equivalencies (MQ&E) Committee Report, Aivee Ortega

- The first MQ & E Committee of the year is to review and provide an overview of what is MQ&E. This year Department chairs where invited. This may be an ongoing process due to MQ&E state handbook changes.
- Aivee attended the <u>ASCCC May 8, 2019 MQ&E regional meeting</u>. ASCCC is spearheading work to come up with an equivalency to the GE and provide examples of what those equivalencies could look like. It was clarified that this mostly applies to disciplines where a degree is not readily available such as Welding or Automotive Technology. It will be the years of experience that will be the priority in terms of content expertise. There are some people who are experts in their field but do not have an associate's degree. This new third equivalency will prompt changes with HR's job advertisement, generate meetings with department chairs and create FLEX training/credit. ASCCC has created a checklist and rubric to help guide this work.
- The meeting also provided an opportunity to learn about other districts MQ&E committee's practices. COC hires mostly during the summer and Aivee is the only person available to review equivalencies as other faculty committee members are off contract. Other districts hire an off season reviewer such as the President, VP of Senate and department chair to review equivalencies. With all the changes happening there may be a need to update the Administrative Procedures. In addition, approving the third GE Equivalency option may come through Senate soon.

C. Action Items

 - Under item #4 there was a question regarding whether there is a minimum for large courses? It was clarified that there is no minimum but the coordinator is encouraged to send the assessment for as many sections as possible.
 - Motion to adopt the recommendations by David Andrus. Seconded by Phil Marceline.
 Unanimous. Approved.
- 2. Progress Standing-Academic Policy, David Andrus
 - b. BP 4250 (pg. 34-36)
 - The title to this document may change. It was stated that the first Academic Policy outlines the work the student has made and the Progress Standing outlines the achievement the student is making.
 - c. AP 4250 (pg. 37-39)
 - Motion to approve BP/AP 4250 policy by David Andrus, seconded by Rebecca Shepherd. Unanimous. Approved.
- 3. Academic Standing-Progress Policy, David Andrus
 - d. BP 4251 (pg. 40-41)
 - e. AP 4251 (pg. 42-45)
 - Motion to approve BP/AP 4251 by Wendy Brill, seconded by Philip Marcellin. Unanimous. Approved.
- 4. CWEE District Plan January 2019, Nicole Faudree (pg. 46-61)
 - The district plan usually goes through BOT and then through Senate. This is the first time the plan has come through Senate and then BOT.

- Motion to approve by Regina Blasberg, seconded by Deanna Riviera. Unanimous. Approved.
- 5. Vote of No Confidence Eloy Oakley Survey Results (pg. 62-63)
 - The current by-laws require a faculty vote to ratify a Vote of No Confidence Resolution. A majority of the voting faculty is required for ratification.
 - An electronic survey was used to conduct the ratification vote. There was a small
 response rate which may have been due to conducting the vote electronically. It was
 shared that a recent CTE Employment survey conducted online only received a 30%
 response rate of which 19% was done via phone. The slow response rate may also be
 attributed to faculty not being well-informed on the Vote of No Confidence issue.
 - Motion to adopt to survey results and acknowledge the resolution by Wendy Brill, seconded by David Brill. Unanimous. Approved.
- 6. Program Viability Evaluation Rubric:
 - Motion to split both rubrics and approve separately by Erika Torgeson, seconded by Wendy Brill. Unanimous. Approved. Philip Marceline abstained.
 - Physical Therapy Assistant Program (pg. 64-71)
 - A correction was made to read as "Physical Therapist" and not "Therapy."
 - The committee asked for letters for clinical sites. This program will be housed under MSHP. There will be a need to go through a new department initiation process. There are accreditation requirements such as a director must be hired before students are in a classroom. The next step will be for Academic Staffing Committee to determine the academic staffing needs.
 - There was a request to take into consideration how this program would benefit
 the college and the community and the many jobs it will create. This employment
 area is projected to increase by 25%.
 - Motion to adopt the Program Therapist Assistant program with the stipulation that a full-time faculty member or a departments takes ownership of the program by Regina Blasberg. No one seconded it, motion did not pass.
 - Motion to table the Physical Therapy Assistant Program by Deanna Rivera, seconded by Wendy Brill, Unanimous. Approved. Philip Marceline abstained.
 - Commercial Music Program (pg. 72-79)
 - Phil MacPherson has been working on this proposal. This is an initiation for a credit Certificate of Achievement. This job listing would find itself in more than one job title. There were some questions regarding the equipment and existing room space. This program would exist in the Music and VAPA departments.
 - It was clarified that a Motion to approve would trigger which faculty and partners need to be identified with the help of Academic Staffing and Micah Young. A no vote would generate more questions regarding supporting new programs.
 - Motion to approve the Commercial Music Program, seconded by Jessica Small. Unanimous. Approved.

Note: Academic Senate President Rebecca "passed the gavel" to Vice President Jason.

- 7. Program Viability, Rebecca Eikey
 - f. BP 4021 (pg. 80-82)
 - Motion to adopt BP 4021 without any modification by David Andrus, seconded by Marco Llaguno. Unanimous. Approved.

- g. AP 4021 (pg. 83-84)
 - There was concern expressed relating to Section B. "Full Academic Senate Action" and how Senate should weigh in on actions related to program viability. This is in reference to program initiation, modification and discontinuance. Finances are uncertain and there is a move towards program discontinuance. There are philosophical concerns regarding placing recommendations of the committees automatically on the consent calendar. There should be more deference given to the Senate president to have further discussion. For example, with the PTA program proposal it was important to have a discussion and not have it be perfunctory. There is an understanding that anyone can pull an item off of the consent calendar. However, the idea of having an item on the consent calendar is to state that the item is not controversial. Senate should have a discussion before taking action or have a general discussion without taking action. There are certain obligations given to the committees but the ultimate responsibility is with Senate.
 - A counter argument was expressed in that much of the committee work is re-done in Senate. Work done in other committees which is placed on the consent calendar can be pulled by any voting member of the senate for further discussion. Part of the motivation for this change was due to the large amount of non-credit work in the Curriculum Committee. Placing these items on the consent calendar would inundate the agenda.
 - There was an agreement to amend the language to state that the President of the Academic Senate will place all recommendations of the Program Viability committee on the agenda. Strick out "as consent calendar items on the agenda of the next regularly scheduled meeting of the Senate."
 - Motion to approve the modifications to AP4021, understanding that if the agenda is ever inundated the AP can come back, by David Andrus, seconded by Erica Seubert. Unanimous. Approved.

D. Discussion

Below are items that the Senate will discuss and no action will be taken. Discussion is welcomed by all attendees.

- 1. Mapping and General Education (GE) Courses, Erika Torgeson (pg. 95-97)
 - The three mapping workshops will be kept very basic but will include concerns, ideas and considerations. Faculty where told to include specific general education courses for their majors without consideration of the effect on enrollment management.
 - An example from the Academic Program Mapping was shared in reference to what those programs will look like. In regards to Phase 1 Basic Mapping should there be prescriptive GE or should it be changed to just the GE heading? Many major courses in Psychology, Sociology, English Composition and History will double count in GE. Students can then pick from electives. Could it be in certain areas of a certain class which could be identified that would be relevant to the major? Whereas, in another area it is not as important. Mapping could also be done by units and not by semester as some students do not enroll in consecutive semesters. Bakersfield College has an interactive program called Program Mapper which helps provide students with alternative choices. Bakersfield has opened up a 2nd cohort and COC has been accepted to participate.
- 2. Meta Majors Proposal, Erika Torgeson (pg. 98)
 - Meta Major Headings are the schools. Color, icon and tagline have not been finalized. Per
 a past resolution, Meta Majors have to be faculty owned. Should Meta Majors be further
 discussed in Senate? Should some sort of action be taken indicating there is an
 agreement, in principle, of what Meta Majors should be or would become? There is an
 understanding that the Meta Majors have now landed as the school titles and they are not

the career clusters such as at Pasadena City College. There was a question regarding how will the proposed re-organization impact the Meta Majors? Should there be recommendations? Should the Meta Majors stay as blended headings? For example, if the school of MSHP splits, would this create a new Meta Major? These are all principles in which Senate should have a "yes" or "no" say. There are many disciplines that should be in more than one Meta Major due to being valuable to the student. Schools could be seen as administrative organizations and Meta Majors could be seen as a centered need to move through curriculum. In a focus group of over 200 students, the students landed on the blended headings. If MSHP were to split, for example, into three schools there would be a need for 3 Senate, Curriculum and CASL seats. In keeping the schools as Meta Majors in regards to data coaches they will know what data to pull for their schools. In the fall work will be done with faculty mentors attached to success teams.

- 3. Starfish/Canyon Connects, Colette Gibson (pg. 99-101)
 - Revision where presented regarding the flagging notification templates. There was a
 request to either allow faculty to create their own notifications or allow editing access the
 notifications templates. It was also suggested to shorten notifications messages.
 - It was reiterated that there is a need to obtain more buy in from the adjunct faculty as they teach 70% of the courses. More outreach needs to done with adjuncts to help with the developmental phase. There is also a need to incorporate FLEX time for adjuncts. Could Guide Pathways be used to help compensate faculty?
 - The next step is to collect information by the next senate meeting regarding what is working so that Julie Johnson can test out the pilot system over the summer.
- 4. Resolution in Support of Climate Change and Environmental Sustainability, Marco Llaguno & Jason Oliver (pg. 102-103)
 - Jeannie Chari, Adam Kaiserman & Marco Llaguno are all a part of the Sustainability Committee. Jeannie has lead the way to trying to make the COC campus more sustainable and recognizing that students have a passion for this. There is much room for growth on campus. One example, is the cafeteria has attempted to implement a food waste diversion program and possibly put this into the next contract for a future vendor. The resolution will need to be cleaned up and "resolves" may need to be expanded to hold the board to a higher standard. The resolve could also be added to the Facilities Master Plan. The hope is to adopt the resolution at the next meeting.

I agree with the name change to Network Technologies, I think it is more appropriate. The things I mentioned in the Advisory Committee meeting was to eliminate the Network Cabling as a full class which you have done but to incorporate a lesson or two about cabling into the Data Center class.

About the VMware classes, the NETECH-213 provides a solid foundation in virtualization technologies from VMware, NETECH-214 takes the knowledge to a whole new level. Anyone with those two classes would have a good strong understanding of VMware. One thing that I would mention and that it is requested a lot from VMware admins is the knowledge of PowerCLI which is Powershell for VMware.

The NSX class, NETECH-215 is not needed as a VMware admin but it will take their knowledge even further. This class is about Software Defined Networking inside the VMware echosystem.

Overall I think you have put a lot of thought into the changes for the program and it looks really good, it does provide the core of networking in the Cisco program and very relevant technologies to be implemented for the foreseeable future.

Hi Erick,

I am looking to make some changes to the Computer Networking program at College of the Canyons and would like your input. I would like to change the name of the program from Computer Networking to Network Technology as the Internet of Things is now headed toward attaching all types of devices to the network, not just traditional technologies (Computers, printers, multifunction devices, smartphones, etc...). I am also working on creating transfer options for bachelors' degrees in networking with San Jose State University and Northern Arizona University so all the courses will be three units to fit the traditional educational system requirements. This will also work with Assembly Bill 288 (AB288) which was written to provide high school students the opportunity for dual-enrollment in college classes during normal high school hours.

The changes to courses required for the Associate Degree are listed in the attached file NETECH- Matrix. I dropped the Network Cabling Infrastructure class and replaced it with the IoT Connecting Things and Python Programming classes. I also added the MCSA: Windows Server OS class needed for the degree.

I am creating three VMware virtualization classes as I think current industry needs justify them. I have attached the course content files for the new courses for your review.

Policy Review Committee Statement

Regarding Academic Department Co-Chair Recognition

On Thursday, August 22, 2019 the Policy Review Committee discussed the appropriateness of Academic Department "Co-Chair" designation. The following represents the findings of the Committee:

After having reviewed the COCFA contract, as well as the Academic Senate's election procedures, the committee reached a unanimous conclusion that the Academic Senate should not reference in any way the existence of Academic Department Co-Chairs. To do so would be a tacit approval of that title that is not authorized by any COCFA or Senate authority. The COCFA contract makes clear there should be one chair of record for department communication and signatures on District forms. Furthermore, since there is no mechanism for electing co-chairs in our election procedures, to have the Senate set precedent by acknowledging a co-chair in any of its documents would be inappropriate.

How departments allocate chair release time is not a matter for Senate action or involvement. This is a COCFA contract compensation matter. This delineation was previously made clear and agreed upon when the Senate addressed the ESES proposed departmental split that was motivated in part by the need for greater compensation.

Academic departments may decide internally how to allocate their release time as authorized by the COCFA collective bargaining agreement. And none of this prevents academic departments from internally referring to and creating co-chairs within their departments. They can call these positions co-chairs, vice-chairs, etc.... The decision to do so is purely their own. But, the Academic Senate should not endorse in any way those titles unless changes are made to all COCFA and Senate documents to recognize such titles. Thus, as of now, any department chair election that allows for the election of co-chairs would be an election process that falls outside the existing Senate procedure for such elections.
