III. Scale of Adoption Assessment (SOAA), **Daylene Meuschke/IE2 Design Team**

- The Scale of Adoption Assessment is a planning tool provided by the state. The NOVA document is College of the Canyons Student Equity and it is a working document. This document is used to help with discussion. The team assesses if COC is at scale with the current efforts. It is not a linear process.
- Progress is tracked through program mapper.
- Equity consideration in each area of focus is embedded while updating the SOAA. Want to make sure this is operationalized and not only documented.
- Important to note that Classified had a voice in this draft especially during IE2.
- The team made sure to acknowledge the other campus projects including AB705.
- This is a detailed action plan to make sure this is institutionalized.
- There has been tremendous progress since starting Guided Pathways in 2015. All feedback and details will not be able to be included in what is sent to the state.
- There are multiple groups across campus that will be hearing this presentation in the next 2-3 weeks.

IV. Basic Needs Center (BaNC)- **Sarah Cox, Director of BaNC**

- This center addresses all the basic needs of students. Services are only available to credit/non-credit students.
- The primary focus is seeing which students are eligible for CalFresh. It

can provide up to \$250 for all grocery stores/some fast food restaurants, discount on Amazon prime membership. It is primarily for low-income students and the application process is about 15 minutes. Staff can help with completing the application in the office.

- Fresh Success-just launched this Spring semester. It has job developers trying to link students to careers. Some services that are included are mock interviews, case management and free book vouchers. The only requirements are that the student is eligible for CalFresh and is in a CTE or a non-credit course.
- The BaNC offers microwaveable food or grab n'go food items at both campuses.
- There is an Emergency Grant Request that students can apply for by filling out a form and depending on the request, Sarah would assess whether the student could receive the grant or not.
- The BaNC tries to provide as many wraparound services as possible, but for example, International students don't apply for CalFresh, but tries to help them out as much as possible.

V. Classified Spotlights:

○ Podcast Studio, **Austin Dave**

- This project has been in the works for the past 3 years. Launching in April 2022, is a new podcast studio that will be community based and student-based.
- MEA will be offering an internship for a student who wants to get involved in production, post-production, engineering, etc...
