 - Joanna Kelly The Classified Senate and Canyons Cares will be hosting the "Money Talks" event tomorrow Wed. Oct. 12th from 11:00am-1:00pm in Canyons Hall-Room 201 at the Valencia Campus. Our speakers are from Logix Federal Credit Union and will be covering how to tackle debt, investment options and the importance of budgeting.  - Dr. Daylene Meuschke and Dr. Jasmine Ruys SEA Plan
 Presentation
 - 5 metrics focused on: 1) Successful Enrollment/Access 2) Math and English Completion in 1st year 3) Transfer Rates 4)
 Persistence 5) Completion rates (earn degrees/certificates within 3 years)
 - The plan needs to be submitted by November 30, 2022.
 - Disproportionately impacted students were highlighted in the plan. Goals were set based on looking at trends and assessing the magnitude of the gaps between groups as well as the group sizes.
 - The IE2 team had high ambitions/goals to close these gaps.
 - Male Black/African American students were one of the DI groups the team wanted to focus on in the upcoming terms.

- It was emphasized that Guided Pathways, SEA plan, etc..were not individualized silo plans, but all interconnected.
- It was noted that IT helped significantly in finding 80,000 "BOTs" that submitted COC applications - this task would have otherwise impacted the data for assessing the amount of students enrolling at COC.

Open forum session based on SEA Presentation

Ideas:

- Many students do not check their student email. This is true particularly for our younger students. The district needs to explore other ways to communicate to students. It is clearly not working.
- It may be beneficial to look at the data regarding students enrolled in classes that were ultimately canceled and whether they re-enrolled in another class during the same term or opted not to.
- Although single sign-on is still fairly recent, it still continues to be a barrier for students. Staff see students consistently getting locked out and resetting passwords.
- The SEA plan should also speak to the impact campus culture is having on students wanting to return to in-person classes. The plan should tie-in with the Facilities master plan, and look to create more spaces for social activities, campus spirit, engagement, fun, etc. SEA should also speak to student service locations, and set goals to move related student services offices into a central location like Canyons Hall. Currently services are disjointed across our campuses.
