Many community colleges, such as LACCD, e.g. Pierce, Antelope Valley, Gavilan, and so on, have two separate critical reasoning courses, one that is akin to our CSU 106 course, and another that is an IGETC course. Having an IGETC course would allow us to maximize our enrollment and qualify our new critical reasoning class as part of certain pathways, e.g. the Law School Pathway, which currently does not include Philosophy, since it has no critical reasoning IGETC course.
