 - The 2022-23 Curriculum Committee Dates are set to be approved at the May 25 Academic Senate Meeting. A calendar will be distributed to the committee once the dates are finalized.
 - No out of discipline prerequisites were requested this academic year, so a special meeting to address this was not needed.
 - Still waiting on IGETC and CSU-GE decisions, latest update is they will be out by the end of this month.
 - Upcoming Legislation reminders:
 - AB 928. Establishment of a <u>SINGULAR</u> lower division GE pathway that meets the academic requirements necessary for transfer into both the UC and CSU segments. Established by May 2023, implemented Fall 2025. Lot of questions from Communications, Foreign Language, Lifelong Learning faculty as to if courses from these areas will be part of the new singular GE pathway. Workgroups are set to meet this summer, more information/guidance to follow.
 - AB 1111. Requires California Community Colleges to establish a Common Course Numbering system, starting with courses included in C-ID and expanding to General Education requirements and transfer pathway courses. Goes into effect July 2024 for 2024-25 college catalogs. An implementation workgroup is part of the new law.
