Discussion Items:

• New CSU-GE Area F, Ethnic Studies (Patrick Backes)

As a result of Assembly Bill 1460, a new Ethnic Studies Area (Area F) is being added to the CSU-GE requirements. This is the first major change to the CSU-GE pattern in 40 years. Area F will consist of 3 units, and Area D will be reduced by 3 units (9 units to 6 units) so no unit increase in the GE pattern. Courses must be available to students beginning in Fall 2021.

To be considered for Area F, courses must have a course prefix that reflects one of the four ethnic groups in the legislation (Native Americans, African Americans, Asian Americans, and Latina/o Americans) or a generic Ethnic Studies prefix. Note: creating required course prefixes can occur without creating new academic departments.

Five Core Competencies for Area F:

- 1. Analyze and articulate concepts of ethnic studies, including but not limited to race and ethnicity, racialization, equity, ethnocentrism, eurocentrism, white supremacy, self-determination, liberation, decolonization and anti-racism.
- 2. Apply theory to describe critical events in the histories, cultures and intellectual traditions, with special focus on the lived-experiences and social struggles of one or more of the following four historically defined racialized core groups: Native Americans, African Americans, Latina/o Americans and/or Asian Americans, and emphasizing agency and group-affirmation.
- 3. Critically discuss the intersection of race and ethnicity with other forms of difference affected by hierarchy and oppression, such as class, gender, sexuality, religion, spirituality, national origin, immigration status, ability and/or age.
- 4. Describe how struggle, resistance, social justice, solidarity and liberation as experienced by communities of color are relevant to current issues.
- 5. Demonstrate active engagement with anti-racist issues, practices and movements to build a diverse, just and equitable society beyond the classroom.

Revising DLA to update existing language for FO (fully online) and PO (partially online), and adding language for FOMA (fully online through mutual agreement) and language for FOIA (fully online with flexible in-person assessment). Also creating a ne DLA for Correspondence Education. We haven't determined how to "house" these in eLumen, or even if we will.

Annual Report to the Academic Senate next week, 10/15. Update will include Curriculum Committee work product numbers from last academic year and Mini-update from Non-Credit.

Blanket Emergency Distance Learning Addendum expires at the close of the FALL semester. Courses without DLA's for 100% Online or FOMA will not be allowed to be offered in Winter and Spring. Deadline to submit DLA's for Winter/Spring course is 10/30, If/when in doubt, submit a FOMA DLA.

The Academic Senate extended the Provisional Online Teaching Training Requirements for Winter & Spring, but those who are only provisionally trained will have to teach all the contact hours in the COR of their course via Online LIVE, or synchronously.
