-Articulation Report, Patrick Backes:

Legislation update.

Budget Trailer Bill (AB/SB 132) Dual Admissions: This new law amends EDC 66744 with UC/CSU dual admission language. Students who successfully complete an ADT or other established course of study at a CCC within two years will have the guarantee of admission to a specific UC/CSU campus. 2023/24 – 2026-27, no end date as it is not termed as a pilot.

AB 927 (Medina): Baccalaureate Degree Pilot: EDC 78040-3 extends the operation of the statewide baccalaureate degree pilot program indefinitely, and removed the requirements that program consists of a maximum 15 community college districts.

AB 928 (Berman) ADT/GE: EDC 66749.8 (new) establishes the Associate Degree for Transfer Intersegmental Implementation Committee to serve as the primary entity charged with oversight of the ADT. Requires ICAS (Intersegmental Committee of Academic Senates) to establish a <u>singular</u> lower division general education pathway that meets the academic requirements necessary for transfer admission into both segments, establish by May 2023 and implement Fall 2025. Requires the CCC's to automatically place students on ADT pathways by August 2024, where student indicates transfer goal on SEP & pathway for major exists.

AB 1111 (Berman) Common Course Numbering: EDC 66725.5 (new): Requires the CCC's to adopt a Common Course Numbering (CCN) system, starting with courses included in the Course Identification Numbering System (C-ID) and expanding to general education requirements and transfer pathway courses. By July 2024, CCN for all GE & Transfer pathway courses, incorporation of CCN into college catalogs.

IGETC Area 7 Ethnic Studies. UC Faculty designed criteria for IGETC Area 7 to align with the CSU Core Competencies. Plan is to go in front of the Academic Senate on November 22nd and then to the Academic Council by December 8th. The goal is for the new IGETC Area 7 to be in the standards that are published in Summer 2022. Submission for course for Area 7 will be open for the following submission cycle (December 2022) and approvals will go into effect for Fall 2023. UC and CSU faculty have been working very hard collaboratively to ensure that criteria for Area 7 are aligned as closely as possible and that students will not be required to take an additional course to meet the requirement.
