Review Process: A confirmation email will be sent within a few days of receiving the application. Grants are reviewed at the next scheduled SCEEC board meeting.

Eligible Participants: All faculty and students in the Santa Clarita Valley are eligible to apply.

Post-project Reporting: One of the benefits to grant receivers is the opportunity to share project results with interested community members. When the funded project is complete, the grantees will be asked to share their story with the grantors. This is typically done at a SCEEC board meeting; however, depending on the project, the board may travel to a location that is best for learning about the project.
