- Data collection of sexuality and gender identity at CCC has limitations on how often students are asked and the types of questions. Currently data is derived from CCCapply where students aged 19 or older are asked and the data does not live in the student information system (i.e. datatel)

### "All Gender" Restrooms

Facilities Representative, Samantha Weber reported on updates for re-signing and converting multi-user restrooms to all gender. The following restrooms have been identified...

The following All Gender restrooms are accessible to students on the Valencia Campus (8 all-gender restrooms; 3 multi-user and 5 single-use)

The availability of these restrooms is until 10pm every day when the buildings are locked, except for the one located in the Library.

- 1. Chancellor's Office side, 2<sup>nd</sup> floor Canyons Hall (Single-use)
- 2. A&R, 1<sup>st</sup> floor Canyons Hall (Single-use)
- 3. PIO, 2<sup>nd</sup> floor Canyons Hall (Single-use)
- 4. Financial Aid, 1st floor Canyons Hall (Single-use)
- 5. Outside Towsley Hall Restroom 1 (Multi-user)
- 6. Outside Towsley Hall Restroom 2 (Multi-user)
- 7. Hasley Hall 3<sup>rd</sup> floor, (Multi-user)
- 8. Library, 1<sup>st</sup> floor circulation area (Single-use; open during Library hours only)
- 9. There is an additional single-use restroom available behind Maker-space, however accessibility to this restroom is limited since students have to walk through makerspace and it is only open during the operating hours of the makerspace.
- 10. Another single-use restroom is available on the 2<sup>nd</sup> floor of the Library available and accessible to *employees* only.

#### **Considerations**



<u>Signage:</u> Federal code requires a pre-set designed wall plate and the State code requires a door sign.

For multi-user restrooms with urinals, a separate sign will be displayed indicating so.

Trashcans for sanitary products: One stall in every men's restroom will have a trash can inside the stall mainly because women's

restroom stalls are built wider to account for the trashcans and adding trashcans may impinge on the required width in pre-existing mens restroom.---Can come up with a consistent system where first/last stall will always include an in-stall trashcan for sanitary products.

Canyon Country Campus (1 single-use inside Health Center

Currently there is one, single-use, restroom in Student Health center and no other restrooms have been identified to re-designate as 'all gender'

### **Lactation Rooms**

### EDC: Title 3, Chapter 4.5. Equity in Higher Education Act 66271.9

- ...reasonable accommodations ...for a lactating student to express breast milk, breast-feed an infant child, or address other needs related to breast-feeding
- (j) The requirements in this section shall be implemented by the California Community Colleges and the California State University, and the University of California is urged to implement the requirements in this section, no later than January 1, 2020.

Certified Lactation Consultant and Certified Lactation Educator Counselor Velia Jimenez who has worked on implementing lactation rooms at CSU, will continue to serve as a resource.

### **Lactation Accommodation**

Senate Bill No. 142 was approved by Governor Newson on October 10, 2019 and becomes effective January 1, 2020. The bill requires an employer to accommodate employees who are lactating or expressing breastmilk by providing a safe and clean room with access to electricity to operate an electric breast pump.
