CAGP NCII 2020 Site Visits – Draft Agenda

Purpose

The California Guided Pathways Project held its last formal institute in September 2019, and CAGP colleges are rolling out version 1.0 of guided pathways in Fall 2020. To support the rollout, CAGP secured additional funding to provide up to 2 college site visits in 2020. The primary purpose of these visit(s) is to provide critical friend support to CAGP colleges as they approach implementation of version 1.0 of GP in Fall 2020 (Visit 1 - Spring) and during the critical first semester of implementation (Visit 2 - Fall).

The visiting team will consist of a senior guided pathways leader such as Kathy Booth, Ed Bowling (CBD Cadre Lead from North Carolina and AACC Pathways Coach), Rob Johnstone or Kay McClenney. Where logistically possible your CAGP Institute Coach and/or your college's CCCCO regional coordinator will join the visit as well. While the visits are customizable to support each college's journey toward rolling out guided pathways at scale, a suggested draft agenda for the first visit is provided below.

We will use two resources designed by NCII & Friends that also use the LMF as an organizing aid and as point of departure for the inquiry: (1) NCII Guided Pathways Resource Series #4 - Key Decisions for Colleges Transforming the Student Experience through Guided Pathways; (2) NCII Guided Pathways Resource Series #5 - Indicators that Your Students' Experience Has Been Transformed by Your Guided Pathways Reforms. The visit can be organized by the "Four
