WHAT IS DEFERRED ACTION FOR CHILDHOOD ARRIVALS (DACA)?

DEFERRED ACTION FOR CHILDHOOD ARRIVALS (DACA) IS A FEDERAL PROCESS THAT DEFERS REMOVAL ACTION OF AN INDIVIDUAL BY USCIS FOR A SPECIFIED NUMBER OF YEARS.

- ***IT IS NOT THE SAME AS FINANCIAL AID***
- ***IT DOES NOT GRANT LAWFUL IMMIGRATION STATUS***
- ***IT DOES ALLOW INDIVIDUALS TO APPLY FOR AN SSN AND WORK AUTHORIZATION***

CA DREAMERS SHOULD STILL FILE A CA DREAM ACT APPLICATION INSTEAD OF A FAFSA AND SUBMIT A NON-SSN GPA.

WHAT IS THE CALIFORNIA DREAM ACT?

- ✓ ***THE CALIFORNIA DREAM ACT ALLOWS UNDOCUMENTED AND NONRESIDENT STUDENTS (U.S. CITIZENS AND ELIGIBLE NON-CITIZENS) WHO QUALIFY FOR A NON-RESIDENT EXEMPTION UNDER ASSEMBLY BILL 540 (AB 540) TO RECEIVE CERTAIN TYPES OF FINANCIAL AID SUCH AS: PRIVATE SCHOLARSHIPS FUNDED THROUGH PUBLIC UNIVERSITIES, STATE ADMINISTERED FINANCIAL AID, UNIVERSITY GRANTS, COMMUNITY COLLEGE FEE WAIVERS, AND CAL GRANTS. IN ADDITION, THE CALIFORNIA DREAM ACT, ALLOWS ELIGIBLE STUDENTS TO PAY IN-STATE TUITION AT ANY PUBLIC COLLEGE IN CALIFORNIA.***

WHO CAN APPLY FOR THE CALIFORNIA DREAM ACT?

- ✓ ***STUDENTS WHO LIVE IN CALIFORNIA AND MEET THE ELIGIBILITY REQUIREMENTS FOR A NON-RESIDENT EXEMPTION, AS WELL AS STUDENTS WHO HAVE A U VISA OR TPS STATUS, CAN USE THE CALIFORNIA DREAM ACT APPLICATION (CADA). SIMILARLY, STUDENTS WITHOUT SOCIAL SECURITY NUMBERS OR STUDENTS WHO HAVE LOST DACA STATUS (OR NEVER APPLIED FOR DACA), MAY STILL BE ELIGIBLE.***



CALIFORNIA DREAM ACT APPLICATION-CONT.

WHO IS ELIGIBLE?

STUDENTS WHO:

- ***HAVE ATTENDED A CALIFORNIA HIGH SCHOOL FOR A MINIMUM OF THREE YEARS;***
- ***GRADUATE FROM A CALIFORNIA HIGH SCHOOL OR PASS THE CALIFORNIA HIGH SCHOOL PROFICIENCY EXAM (CHSPE) OR GET A GENERAL EQUIVALENCY DIPLOMA (GED);***
- ***ENROLL IN AN ACCREDITED AND QUALIFIED CALIFORNIA COLLEGE OR UNIVERSITY;***
- ***FILL OUT AN AFFIDAVIT TO LEGALIZE IMMIGRATION STATUS AS SOON AS ELIGIBLE.***

CALIFORNIA COLLEGE PROMISE GRANT - CCPG

- ✓ ***THE CALIFORNIA COLLEGE PROMISE GRANT, FORMERLY KNOWN AS THE BOARD OF GOVERNORS ENROLLMENT FEE WAIVER (BOGFW), WAIVES ENROLLMENT FEES FOR QUALIFIED STUDENTS FOR THE ENTIRE SCHOOL YEAR. STUDENTS MAY RECEIVE A WAIVER FOR ANY NUMBER OF UNITS, WITH NO MINIMUM.***
- ✓ ***YOU MAY QUALIFY IF YOU HAVE SOME FINANCIAL NEED, RECEIVE TEMPORARY ASSISTANCE TO NEEDY FAMILIES (AFDC/TANF), SUPPLEMENTAL SECURITY INCOME/SSP OR GENERAL ASSISTANCE AND THOSE WHO MEET CERTAIN INCOME STANDARDS.***
- ✓ ***THE CALIFORNIA COLLEGE PROMISE GRANT (BOARD OF GOVERNORS FEE WAIVER) ONLY WAIVES ENROLLMENT FEES (\$46 PER UNIT)*. YOU ARE RESPONSIBLE TO PAY ANY FEES NOT COVERED BY YOUR AWARD AT THE TIME OF REGISTRATION TO AVOID BEING DROPPED FOR NON-PAYMENT.***

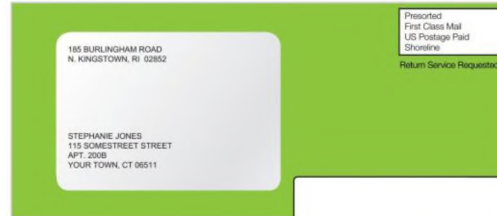
