2019-2020 Dependent Verification of IRS Nonfiling Status

Your 2019-2020 Free Application for Federal Student Aid (FAFSA) was selected for a process called "verification". Verification is a procedure through which an institution checks the accuracy of the student and parental information reported on the FAFSA. The U.S. Department of Education requires that we verify the tax filing status of your parent(s) before disbursing federal financial aid. Parents that did NOT file a federal tax return, must submit a Nonfiling Status Letter obtained from the IRS. Parents unable to obtain a Nonfiling Status Letter from the IRS, OR parents that do NOT have a SSN, an ITIN, or an EIN who are unable to obtain a Nonfiling Status Letter from the IRS - MUST complete this verification form and submit it to the Financial Aid Office at College of the Canyons.
