## 2020-2021 Independent Verification of IRS Nonfiling Status

Your 2020-2021 Free Application for Federal Student Aid (FAFSA) was selected for a process called "verification". Verification is a procedure through which an institution checks the accuracy of the student and spouse information reported on the FAFSA. The U.S. Department of Education requires that we verify your tax filing status before disbursing federal financial aid. Students that did NOT file a federal tax return, must submit a Nonfiling Status Letter obtained from the IRS. Students unable to obtain a Nonfiling Status Letter from the IRS, OR students that do NOT have a SSN, an ITIN, or an EIN who are unable to obtain a Nonfiling Status Letter from the IRS - MUST complete this verification form and submit it to the Financial Aid Office at College of the Canyons.
