<b>Background:</b> The outgoing 2022-2023 ASG Senate approved ASG's tentative operating budget for 2023-2024. Since then, year-end totals have been calculated including total revenue received from the Student Support Fee. Unfortunately, Student Support Fee revenue has been steadily decreasing over the past several years due to enrollment trends resulting most recently in a \$150,000 shortfall in anticipated Student Support Fee funds for 2022-2023.
While ASG has been able to sustain its budget due to healthy monetary reserves in recent years, those funds have significantly decreased. As a result, cuts need to be made to this year's ASG's budget.
